Pioneer Herbals (Unit-II)., Sr. No. 175/2-B, Building no. 2, Dabhel, Nani Daman was issued consent to establish for manufacturing of "Hair care products-5 lac pcs/Annum, Skin care products-3 lac pcs/Annum, Home care products-2 lac pcs/Annum, Toiletry products-2 lac pcs/Annum and Ayurvedic pain balm-0.5 lac pcs/Annum (no other items)." under Water and Air act valid upto 28/02/2017. The activity falls under Category-III.

- ➤ Raw materials used in manufacturing process were various types of oils and cosmetic items as listed in application form no. XIII under Water Act.
- > Product being manufactured at the time of inspection was Hair care products.
- Manufacturing process involved in the unit were mixing & blending of raw materials and packaging.
- > Housekeeping observed was in good condition.
- ➤ ETP was installed in the premises of the unit which comprises of collection tank-Primary settling tank-Primary clarifier-mixed bed filter-treated water tank-notch filter and sludge storage area.
- ETP was not in operation at the time of inspection because of less quantity of generated influent.
- > Influent for ETP is generated from the washing of floor in manufacturing unit and washing of storage containers.
