Under the Scheme, Scholarships are awarded to students from notified minority communities for pursuing professional and technical courses, at under-graduate and post-graduate levels in institutions recognized by the appropriate authority, who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian, from all sources does not exceed Rs. 2.50 Lakhs.

OSMS has been introduced from the year 2011-12. The site is accessed through the URL www.momascholarship.gov.in. A link to the site is also made available in the website of Ministry i.e. www.minorityaffairs.gov.in.

It is reiterated that only online applications under Marit-cum Means Based Scholarship scheme will be accepted from this year and no request for accepting Offline applications will be entertained.

In the meeting of Administrator's Advisory Committee on Minorities held on 26/12/2013, the Hon'ble Administrator has directed to the Secretary Education to set up help desks to provide assistance to desirous students for applying for scholarship online.

The renewal proposal under Marit-cum-Means (MCM) Based Scholarship Scheme for which the application will be received online from the month of June for the year 2014-15.


All the applicants are advised to take print-out of the duly filled-in application forms, through OSMS, and to submit the same alongwith all supporting documents through their respective institutes to the **Assistant Director of Education, Daman and Education Officer, Diu.**

It may also be noted that without receipt of hard copy in the District, State/ UT Department, the application is likely to be rejected.

Attention of the students is also invited that the FAQs available on the homepage of the website for filling up of online application.

Please ensure that Bank Account and Aadhar Number of the Student should be complete and accurate, failing which the application form is likely to be rejected.

Last date for submission of Online Applications is **15th September, 2014** and last date of renewal case is **15th November, 2014**. Last date of duly signed printed version of Online Applications to Department through respective institutes for fresh case & renewal case is **25th September, 2014 & 20th November, 2014, respectively.**

I am directed to say that the Merit-cum Means based Scholarship Scheme is a Centrally Sponsored Scheme launched in the year 2007. Under the scheme, Scholarships are awarded to students from notified minority communities for pursuing professional and technical courses, at under-graduate and post-graduate levels in institutions recognized by the appropriate authority, who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardian, from all sources does not exceed Rs. 2.50 lakh. **From 2014-15 Merit-cum Means based Scholarship Scheme is a Central Sector Scheme with 100% Central funding.**

2. The Community-wise Physical allocation are enclosed at (Annexure - I) for Fresh Scholarship in respect of your State Government/UT Administration under the scheme of Merit-cum Means based Scholarship scheme for students belonging to minority communities along with **Timeline** for the financial-year 2014-15. **As far as, Renewals of Scholarships are concerned, there is no target for them.**

3. States/UTs are aware of the fact that Online Scholarship Management System (OSMS) has already been introduced in the Merit-cum Means based Scholarship Scheme, from the year 2011-12. The site can be accessed through the URL www.momascholarship.gov.in. A link to the site is also made available in the website of this Ministry i.e. www.minorityaffairs.gov.in. **It is reiterated that only Online applications under Merit-cum Means based Scholarship Scheme will be accepted and no request for accepting Offline applications will be entertained. This may be brought out clearly in the Advertisement.**



Applicants may also be advised to take print-out of the duly filled-in application forms, after submitting it Online through OSMS, and to send it alongwith all supporting documents through their respective institutes to the District, State / UT Department. **It may be highlighted that without receipt of hard copy in the District, State / UT Department, the application shall be liable to be rejected.**

8. The State/UT should fulfill all terms and conditions contained in the Scheme at the time of submitting the proposals. It may also be ensured that proposals are submitted along with Utilization Certificate in GFR-19 A.

9. The State Governments/UT Administrations are also advised to indicate to this Ministry, the status of disbursement of scholarships released in the year 2013-14. The State Governments/UT Administrations must upload on their respective websites, the detailed list of students who were given scholarship in the previous year so that the same could be hyperlinked with the website of this Ministry. **Failure to place the list of beneficiaries for the year 2013-14 may result in non-consideration of proposals.**
