In exercise of the powers conferred by sub-sections (1) and (2) of Section 301 read with section 138, 250, 257, 258, 261, 263, 264 and section 317 of The Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation, 2004, the Silvassa Municipal Council hereby makes the following Draft Bye-Laws. These Bye-Laws are hereby published, as required by clause(b) of sub-section (3) of Section 301 of the said Regulation, and notice is hereby given that the draft of the said bye-laws will be taken into consideration on the expiry of 15 days from the date of publication of this notification.

Any person who intends to make any objection or suggestion regarding these draft Bye-Laws may send the same to the Chief Officer, Silvassa Municipal Council, Dadra & Nagar Haveli and Daman and Diu, Union Territory within the period specified above.

Any objections or suggestions, which may be received by the Chief Officer, Silvassa Municipal Council, Dadra & Nagar Haveli, within the aforesaid period shall be considered by the council.

Draft Bye-Laws

Short Title- (1) These Bye-Laws may be called the **Silvassa Municipal Council Trade and Occupation and licencing Bye-Laws, 2023.**

(2) They shall come in to force from the date of their publication in the Official Gazette.

Definitions. - In these Bye-Laws, unless the context otherwise requires,

- 'Regulation' means the Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation, 2004 as amended from time to time;
- 'Licensee' means the person to whom a licence has been granted under these Bye-Laws and includes the persons nominated by him in the licence to carry on some trade or occupation on his behalf;

- (iii) 'Licensed Premises' means the premises in respect of which the licence has been granted under these Bye-Laws;
- (iv) 'Manager' means a licensee himself or a person appointed by the licensee to run the trade or occupation on his behalf;
- (v) 'Person' includes juristic persons but excludes Central or State Governments and UT administration of Dadra and Nagar Haveli and Daman and Diu.
- (vi) 'Schedule' means a Schedule appended to these Bye-Laws.
- (vii) 'Trade' means any business or commercial activity which are shown in the Schedule appended to these Bye-Laws;
- (viii) 'Occupation' means any purpose for which the premises are occupied other than for residential, religious, educational or charitable or non-profitable purposes.

Bye-Law 1. No Person shall, except under and in accordance with the conditions of a licence granted under these Bye-Laws, keep or allow to be kept in or upon any premises in the Municipal area any of the articles specified in the Schedule or use the premises to transact the trades or occupations as specified in the Schedule.

Bye-Law 2. The licence to be granted under Bye-Law 1 shall be in **Form 'A'** appended hereto.

Bye-Law 3. Any person desiring and entitled under these Bye-Laws to carry on any trade or occupation mentioned in these Bye-Laws or in the Schedule may apply through the President to the Chief Officer for a licence in the prescribed **Form 'B'**.

Provided that those already carrying on such Trades and Occupations shall within **60 days** from the date on which these Bye-Laws come into force, apply through the President to the Chief Officer for a licence of such Trades and Occupation.

Bye-Law 4. After obtaining recommendations of the President, Silvassa Municipal Council, the Chief Officer may grant or refuse to grant the licence applied for duly signed by the President, Silvassa Municipal Council. If the licence is refused, the reasons for refusal shall be stated in the order of the refusal.

Provided that if the President provides no recommendation within five days of matter coming to his knowledge, it shall be presumed that he/she has recommended grant of license.

Provided further that if the refusal is not communicated to the applicant within 30 days of the application being filed, the application shall be deemed accepted.

Bye-Law 5. Every licence shall expire at the end of the licencing year i.e. 31st March, and it shall be renewed during the months of April/May on payment of the fees prescribed under the Schedule and on presentation of other certificates/permissions as may be required under Bye-Law 28 of these Bye-Laws. If the renewal fee is not paid within the time-limit prescribed in this bye-law, then the applicant shall be liable to pay penalty at the rate of 5% of the license fee for each month's default till the beginning of next financial year after which the license shall automatically stand cancelled. However, the applicant shall be entitled to get the license renewed **on payment of fine of Rs. 1,000/-, and previous penalties. All penalties imposed under these bye-laws shall be recoverable as arrears of property tax.**

Bye-Law 6. The licence fees chargeable in respect of a Trade/Occupation or for the purpose shown in column 2 of Schedule shall be as shown in the respective column against the item concerned. An establishment that deals in multiple trades and occupations shall be liable to pay a sum of fees applicable for all such trades and occupations.

Bye-Law 7. Every person applying a licence through the President to the Chief Officer shall submit the application in writing, in the prescribed **Form 'B'** and shall also furnish the details of the premises such as location, area, reference to payment of House Tax, plans of the premises, Certificate of Registration, N. O. C. from the owner, lease deed, rent receipts, number of employees' employed or such other details as may be decided by the Chief Officer from time to time.

- Bye-Law 8. The licensee shall adopt measures as may be required by the Chief Officer for the prevention of all nuisance by smoke, gas, vapour, dust, fumes, smell, noise or other such impurities and cause all materials not required for immediate use to be kept in such manner so as to prevent the harmful or injurious effluvia therefrom. No business or process of manufacture undertaken in a factory or workshop or a place of business to whom licence is granted under these bye-laws shall create any nuisance such as noise or unreasonable pollution to the nearby residences.
- Bye-Law 9. The licensee shall provide in the premises proper water supply, washbasins, and toilet/urinal facility whenever specific trade or occupation so demands, according to the satisfaction of the Chief Officer—who shall, in the exercise of such satisfaction, be bound by all decisions of the council as resolved from time to time—and in compliance with the Solid Waste (Handling and Management) Bye-Laws, 2018, as amended from time to time.
- Bye-Law 10. The licensee shall cause all the refuse matter from the premises to be collected and deposited in suitable covered, impervious receptacles. He/she shall cause all the refuse to be removed at least once a day and deposit the same in the door to door waste collection vehicle of the council or place the same in such Municipal dustbin as may be resolved by the council.
- Bye-Law 11. The licensee shall get his premises toilets and drains connected with sewerage system of the council if the same is feasible and available.
- Bye-Law 12. The licensee shall provide sufficient light and ventilation in the premises wherein the trade and occupation is carried out.
- Bye-Law 13. The licensee shall get all his employees medically examined by a Government Health Officer, or Health Officer of the Council, or any private practitioner and maintain their respective health cards, which shall be renewed annually and which shall be produced to the Chief Officer or any other Officer duly authorised by him/her, on demand.
- Bye-Law 14. The licensee shall cause to take all precautions to avoid fire hazards, especially in respect of the shops dealing with inflammable products, etc.
- Bye-Law 15. The licensee shall cause to pay in the Municipal Office fees in respect of advertisement, wall paintings including name boards/name of the shop displayed at the premises as per the Tax on Advertisement Rules, 2018.
- Bye-Law 16. The Chief Officer may delegate in writing, with the council's permission, any powers vested in him under these Bye-Laws to any other Municipal Officer under his control.
- Bye-Law 17. The licensee shall also follow these conditions, wherever applicable:
- (i) the licensee shall keep the premises and all the equipment in clean and hygienic conditions and keep disinfectants to be provided on demand;
 - (ii) no person suffering from an open sore or any loathsome, infectious or contagious disease shall be permitted to carry on the business of a barber or be employed in or to assist in the carrying on the business of spa, saloons, Hamam khana etc. and the licensee shall obtain a medical certificate every year from the Government Health Officer or private practitioner to the effect that the employees are free from diseases or infection of any kind and fit for employment in such business;
 - (iii) shall provide the scales approved by the Controller of Weights and Measures when used.
 - (iv) The licensee shall keep the licensed premises in a clean condition at all times and take reasonable precautions regarding the storage of meat, milk, and other articles of human consumption to avoid its deterioration and contamination.
 - (v) All utensils used in cooking or serving food articles shall be kept in a clean and hygienic condition.
 - (vi) Every person employed in the licensed premises for selling, preparing, cooking, or serving food shall, at all times, be dressed in clean clothing. The licensee shall not employ any person suffering from any infectious disease in the premises in any capacity.

- (vii) No impediments or encroachment shall be made on the footpath or public road in front of the licensed premises by placing thereon such as chairs, benches, tables, soda water boxes, or any other articles for the use of the licensee or his customers.
- (viii) The floor of every cooking room, or kitchen and eating room or dining hall shall be paved to the satisfaction of the Chief Officer or such other officer as may be authorised by him or the council, and the cooking room or kitchen shall be separated from the eating room or dining hall.
- (ix) The licensee shall use a metal bin or metal lined wooden box for the storage of any coal, coke or charcoal or firewood required for the preparation of food. Such bin or box shall be located in a place approved by the Chief Officer or any other officer authorised in this behalf by him or by the council.
- (x) The licensee shall provide a proper washing place for cleaning dishes, cups, etc.; such washing place shall not be in the room reserved for consuming eatables. It shall be adequately drained and connected with the Sewage Treatment plant on the premises of the hotel (if the eating place is in a hotel and the hotel is required under any law to have a STP) or with a sewerage network after making provisions for proper grease trap or if no sewerage network is yet available with a septic tank and soak pit.
- (xi) Licensee of the place where food and beverages are stored and who are bulk waste generators should mandatorily do onsite composting of the food waste. Every other licensee who does onsite composting shall be given a lump-sum discount of 5% on the license fee.
- (xii) Licensee shall, in premises where sleeping accommodation is provided, follow the conditions related to hygiene or safety as are directed by the Chief Officer or are resolved by the council from time to time.
- (xiii) Licensee shall follow any other conditions as may be resolved by the council in its General Body meeting.

Bye-Law 18. Every person who does or *omits* to do any act in contravention of any provisions of these bye-laws shall be liable to a fine of 25 % of the licence fee for each default and shall also be liable to get the license revoked at the discretion of the Chief Officer.

Bye-Law 19. Any licensee aggrieved by any decision of the Chief Officer may, within 30 days from the date of such grievance, submit an appeal to the Standing Committee, and the Standing Committee shall decide upon his appeal within the provisions of these bye-laws. If any difficulty arises as to the construction or meaning of these Bye-Laws, the decision of the Standing Committee in this regard shall be final.

The Chief Officer shall, in the execution of his decision, abide by the directions of the Standing Committee as appellate authority. Provided that, if in the opinion of Chief Officer, such decision is ultra vires, illegal, unfair, or not in the public interest, he shall refer the same for the decision of Director, Municipal Administration and shall abide by such decision.

Bye-Law 20. A Licence is valid only for the premises specified in the licence, and if the licensee desires to carry on such trade or any occupation connected therewith, in additional room or space, he shall apply for a fresh licence.

Bye-Law 21. **Cancellation of License:-**

- a. Suppose the licensee vacates, or gives up possession of the premises, or otherwise desires to stop the business during the period of the licence, he shall forthwith inform the Chief Officer of the same, and the Chief Officer shall, if no due is pending, forthwith cancel the license.
- b. If any other person comes to the knowledge that the licensee is carrying on a business in the premises, which he is otherwise, by virtue of any law, rule, bye-law in force, not permitted to carry, he may inform the Chief Officer in writing. In that case, the Chief Office, after giving the licensee a reasonable opportunity of showing cause, shall take such decision as the circumstances of the case may demand.

Bye-Law 22. **Transfer of license:** A license is not transferable either as regards the person to whom it is granted or the premises for which it is granted.

- Bye-Law 23. The licensee shall cause such licence to be affixed in some conspicuous part of the licensed premises.
- Bye-Law 24. The licensee shall, at all hours, while the licensed premises are open, allow the municipal officers above the rank of Sanitary Inspectors or such other officers as may be authorised by the Chief Officer or the council, to enter his premises, and afford every facility for inspecting the place, also the vessels, articles of food or drink, or the furniture and shall comply with the directions that the Chief Officer may give in writing for securing cleanliness, light, and air, or otherwise.
- Bye-Law 25. The licensee shall be liable to suspension or revocation if the licensed premises are so kept, or any process or operation connected with it is so carried on as to be, in the opinion of the Chief Officer, a source of nuisance or danger to life, health or property.
- Bye-Law 26. The Licence fee shall increase automatically **biennially by 6 %**. Any fraction shall be rounded to the nearest rupee.

Provided that in case of natural calamities, disasters or pandemics, which have affected the business environment of the area within the jurisdiction of the council, the council, may by a resolution, remit part or whole of the license fee applicable to any licensee or all licensees of an area or of the entire council as the council may deem equitable.

Provided that following class of citizens shall be entitled to discount in license fee as mentioned against their name.

- (i) Widows aged 40 and above:- 50%
- (ii) Other widows :- 25%
- (iii) Senior citizens of age 70 and above:-50%
- (iv) Senior Citizen of age between 60 and 70:- 25%
- (v) Physically handicapped of 40% and above disability:-50%
- (vi) Females:- 10%

- Bye-Law 27. Every person who does or omits to do any act in contravention of any provisions of these bye laws shall, if no other penalty is provided for the offence in the Regulation, on conviction be punished by punishment as provided in section 282 of the Regulation.
- Bye-Law 28. Non Exclusivity of These Bye-Laws:- Notwithstanding anything contained in these bye-laws, the applicant shall have to obtain all such licenses, certificates or other permissions as he/she was required to do in other acts, rules or bye-laws.
- Bye-Law 29. Street vendors shall not be required to obtain more than one license from the council and shall also not be required to pay any other than what is required of them under other applicable laws, rules and bye-laws.
- Bye-Law 30. Any reference to, or any words used for male shall, unless the context otherwise requires, include reference to females.
- Bye-Law 31. Schedule appended to these byelaws shall stand amended by simple resolution of the council provided that,
- a. Prior approval of the Director Municipal Administration is obtained before notifying the same.
 - b. The new rates or the new items included therein shall be published in at least two local newspapers.
