#### **NOTIFICATION**

In exercise of the powers conferred by the provision to Article 309 of the Constitution read with the Government of India, Ministry of Home Affair, Order No. 7/1/65-Est.(A) dated 16<sup>th</sup> February, 1965 and Department of Personnel and Training, New Delhi O.M. No. AB/14017/61/2008-Estt. (RR) dated 24<sup>th</sup> March, 2009, the Administrator of Daman & Diu pleased to make the following Rules relating to recruitment to the General Central Services Group 'B' (Non-Gazetted, Non-Ministerial) post of Industry Promotion Officer under the Director of Industries, Administration of Daman and Diu, namely

# (1) SHORT TITLE APPLICATION AND COMMENCMENT:

- (i) These rules may be called the Administration of Daman and Diu, **Industry Promotion Officer**, Director of Industries, Daman & Diu for Group 'B' (Non-Gazetted, Non-Ministerial) post Recruitment Rules, 2011.
- (ii) They shall apply to the posts specified in Column -1 of the Schedule to these rules.
- (iii) These rules will come into effect from the date of publication of this notification in the official Gazette and will relate to appointment to the various posts made on or after this date.

### (2) NUMBER OF POSTS, CLASSIFICATION AND SCALE OF PAY:

The number of posts, classification of the said posts and scale of pay attached thereto shall be as specified in columns 2 to 4 of the schedule to these rules: Provided that, the Administrator of Daman & Diu may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

# (3) METHOD OF RECRUITMENT, AGE LIMIT, QUALIFICATIONS ETC:

The method of Recruitment to the said posts, age limit, qualifications and other matters connected therewith shall be as specified in columns 5 to 13 of the aforesaid schedule.

### (4) <u>DISQUALIFICATION</u>:

No person (a) who has entered into or contracted a marriage with a person having a spouse living, or (b) who, having a spouse living, has entered into or contracted a marriage with any persons, shall be eligible for appointment to the service Provided that the Administrator of Daman & Diu may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

### (5) **POWER TO RELAX:**

Where the Administrator of Daman & Diu is of the opinion that, it is necessary of expedient so to do, it may, by order, for reasons to be recorded in writing, and in consultation with the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, New Delhi and Union Public Service Commission, relax any of the provision of these rules with respect to any class or category of persons.

### (6) SAVING:

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Caste and Scheduled Tribes, and other special categories or persons in accordance with the order issued by the Central Government from time to time in this regard.
