General

- 1) Sealed envelope should be super-scribed "Limited Tender for Hiring Vehicles"
- 2) Tenderer shall have to deposit Rs.1000/- (Rupees One Thousand only) for Tender fees (non-refundable) by Demand Draft in favour of Deputy Director (Transport)" payable at Dadra and Nagar Haveli Silvassa. The tender fees submitted in any from other than mentioned above will not be accepted. Tender received without Tender fees will be summarily rejected.
- 3) The rate should be quoted in the prescribed form given by the department; the rate should be inclusive of all taxes and should be valid up to one year from the date of issue of supply order.
