The objective of the Scheme is to support to parents of ST Students for Education of their wards studying in classes IX and X so that the incidence of dropout, especially in transition from the elementary to Secondary and during Secondary stage of Education , is minimized. A copy of the guide line of the Scheme is enclosed for more details.

Applications are invited from ST students, pursuing from Class IX and X in Govt. / Aided / recognized by Govt. or a central /State Board of Secondary Education.

For being eligible under this scheme,

- a) Student should belong to Scheduled Tribe.
- b) Her / his Parent /Guardian's income should not exceed **Rs. 2 Lakh per annum.**
- c) She/he should not getting any other centrally –funded Pre-Matric Scholarship.
- d) Should be regular, full time student studying in a Government School or in a School recognized by Govt. or a Central/State Board or Secondary Education.

Scholarship for studying in any class will be available for only one year. If a student has to repeat a class, she/he would not get scholarship for that class for a second (or subsequent) year.

Filled up the application form with requisite documents should be submitted to the office of Assistant Director of Education , Nani Daman through the Head of School being attended by the students.

Head Master should thoroughly examine the Application form submitted by the Students before submitting this office with the required information **as per proforma-** enclosed in both hard copy and soft copy. This will enable the Ministry to release admissible Central Assistance through Social Welfare Department at the earliest.
