TERMS AND CONDITIONS FOR AUCTION OF VEHICLES CONFISCATED BY EXCISE DEPARTMENT, DAMAN

- 1. Interested Party may submit their highest price for the confiscated vehicles put on auction in a sealed cover latest by 5.00 pm on 30 104/2023. The inner cover containing quotations and other relevant documents along with Earnest Money Deposit (EMD) in Cash should be sealed properly. The quoted price must be higher than the offset price fixed by the Excise Department, DAMAN. The inner cover should be put in on the outer cover and maybe deposited to Excise Department, Daman. Both the inner and the outer covers should be superscribed in bold Capital letters "(QUOTATIONS FOR VEHICLES CONFISCATED BY EXCISE DEPARTMENT, DAMAN)".
- 2. The disposal of confiscated vehicles shall be strictly on "AS IS WHERE IS BASIS". The condition of the vehicles can be inspected physically from 104/2023 to 3/04/2023 between 11:00 a.m. to 05:00 pm at Excise Department, Daman by contacting Excise Guard Posted in Excise Office. Tender forms with terms and conditions for submitting tenders can be downloaded from the Departmental website i.e. https://ddnexcise.gov.in
- 3. The quotation should be accompanied by earnest money i.e. Rs 50,000/- (Rs. Fifty Thousand Only). The EMD should be attached with the quotation letter failing which the quotation shall not be considered. If the highest tenderer/successful tenderer accepted by the department fails to deposit the sale price within the prescribed time limit i.e. within 02 working days from the date of intimation to the tenderer(s) declared as highest bidder by the department, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.
- 4. The quotation should be accompanied by GST registration of the scrap company/agency along with all the legal documents of the company/agency.
- 5. The offered amount for each vehicle will be including all kind of taxes.
- 6. EMD of Rs. 50,000/- for the auction of vehicles is payable by means of Cash. Offers received without EMD amount shall not be considered at all by this Department.
- 7. EMD of the successful bidders(s) will be released only after the realization of the Sale proceeds amount. Earnest Money Deposit of the bidders who fail to honor the bid in the prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD of unsuccessful bidder(s) shall be released only after the successful completion of the sale process.
- 8. The delivery of the Vehicles will be arranged only after the successful bidder submits documentary evidence in support of payment of tendered amount via online mode (UPI or Net Banking) in Excise Department, Daman.

- 9. The sold vehicles will be removed by the successful bidder(s) within 2 days from the date of intimation to the tenderer(s) declared as the highest bidder. No assistance/transportation will be provided by the Department. Permission to take out the sold vehicles from the premises will not be allowed on holidays, Sundays etc.
- 10. EMD of the bidder rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. The decision of the Department shall be final in this regard.
- 11. Department of Excise, DAMAN reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
- 12. EMD of the unsuccessful bidder shall be returned maximum within 02 Days from the date of declaration of the Highest bidder or successful bidder.
- 13. The bidder is required to reveal his full name/name of the authorized signatory of the agency, full postal address, telephone number & mobile number.
- 14. Disputes, if any, arises shall be adjudicated by Deputy Commissioner of Excise, DAMAN.
- 15. If the highest quoting party fails to honor the bid, the bid will be cancelled & its EMD shall be forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (Second highest quoting party) to complete the bid provided it is prepared to accept the prices offered by the Highest quoting party. In case of any dispute, the decision of the Department shall be final.
- 16. Tender form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by an authorized signatory shall be rejected.
- 17. Tendering party shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
- 18. Quotation should be offered in the prescribed tender form as given in Annexure-I.
