ORDER

WHEREAS, the General Election to Rural Local Bodies viz Gram Panchayats and District Panchayats of the UT of Dadra and Nagar Haveli and Daman and Diu were held in the year 2020 and similarly the first meeting for the District Panchayat were held on 19.11.2020 and as such, the term of the District Panchayats of UT of Dadra & Nagar Haveli and Daman & Diu had commenced with effect from **19.11.2020** as per Notification No. 3/48/DIR/PE/DMN/2015-16/355 dated 13.11.2020;

AND WHEREAS, as per Section 61 (6) of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012, the term of the President and Vice President shall be maximum of two years and six months from the date they are appointed for its first meeting and no longer, and the reservation of the posts of the President and Vice President shall be as per the proviso of Section 61(5) and the gazette notification accordingly issued by the UT Administration of Dadra & Nagar Haveli and Daman & Diu dated 23/11/2020 vide No JS(PRI)/DMN/Misc-Matters/2020/364;

AND WHEREAS, the term of the present President and Vice President of the District Panchayats of Dadra and Nagar Haveli and Daman and Diu shall be concluding on **18.05.2023** on completion of two years and six months from the date they are appointed for its first meeting.

Now therefore as per the provision of Section 61(1) and Section 61 (2) of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012, read with the Dadra and Nagar Haveli and Daman and Diu (Adaptation of State Rules and Presidential Regulations) Order, 2020 dated 08.10.2020,

read along with Rule 16 of the Daman and Diu Election of Upa-Sarpanch of a Gram Panchayat and President and Vice President of District Panchayat Rules, 2013 and the Dadra and Nagar Haveli and Daman and Diu Election of Upa-Sarpanch of a Gram Panchayat and President and Vice President of District Panchayat Rules, 2014 and in pursuance to the Notification No. JS (PRI)/DMN/Misc-Matters/2020/364 dated 23.11.2020, the Secretary (PRI), Dadra & Nagar Haveli and Daman & Diu appoints the following Officers as the Presiding Officers and fix **18th of May, 2023** as the date when the meeting of the District Panchayat of Dadra and Nagar Haveli and Daman and Diu Districts shall be called for the election of President and Vice-President of the respective District Panchayats for the remainder term of two years and six months with effect from 19.05.2023 onwards:
