In exercise of the power conferred under Rule 87 of the Juvenile Justice (Care and Protection of Children) Model Rules. 2016. the Administrator of the U.T. Administration of Dadra and Nagar Haveli and Daman & Diu is pleased to re-constitute a Selection Committee for selection of Chairperson and Members of Child Welfare Committee(s) and Members of Juvenile Justice Board (s) for Dadra & Nagar Haveli and Daman & Diu, consisting of the following:-

1 Hon'ble Shri Justice K. L. Wadane (Retired) - Chairperson

2 Law Secretary, Dadra and Nagar Haveli and Daman & Diu - Member

3 Chairperson of the UT Commission for Protection of Child - Member Rights

4 Principal Govt. College. Daman - Member

The committee shall have tenure of three years and the appointment of members shall be co-terminus with the tenure of the committee. The Selection Committee shall perform its duties as per provision of Juvenile Justice (Care and Protection of Children) Act, 2015 and the Juvenile Justice (Care and Protection of Children) Model Rules, 2016. The major duties of Selection Committee are detailed as under:

- 1. Remuneration of Rs. 10.000/- shall be paid to the Chairperson of the Selection Committee per sitting and also the Chairperson shall be entitled for Travel Allowance (T.A.) and Dearness Allowance (D.A.) as actual.
- 2. The Selection Committee shall evaluate the candidates on the basis of qualification, experience of working with children and personal interaction with the candidate.
- 3. On the basis of the evaluation procedure and criteria, the Selection Committee shall select and recommend a panel of names in order of merit to the State Government for appointment as Members of the Juvenile Justice Board(s) or Chairperson or Members of the Child Welfare Committee(s) as the case may be.
- 4. The Selection Committee shall also prepare list of names for the Child Welfare Committee(s) and Juvenile Justice Board(s) to fill up vacancies, which may arise during the tenure of the Child Welfare Committee(s) and Juvenile Justice Board(s) respectively.
