With reference to the above cited subject, a Notification No. 7-5/EC/DNH&DD/2022, dated 19/05/2023, issued by the Election Commissioner, Election Commission for UTs, New Delhi regarding delimitation for newly constituted Gram Panchayats in Diu District is hereby published in the Official Gazette of this UT Administration of Dadra & Nagar Haveli and Daman & Diu for General information.

NOTIFICATION

No. 7-5/EC/DNH&DD/2022: Whereas, the last delimitation of wards of Gram Panchayats in Daman and Diu districts of UT of Dadra and Nagar Haveli and Daman and Diu was notified on 13th May, 2015 by this Commission;

And whereas, the Administrator, Dadra and Nagar Haveli and Daman and Diu, keeping in view the large population of Vanakbara and Saudwadi Gram Panchayats, has split the said Gram Panchayats into three Gram Panchayats each thereby increasing the total number of Gram Panchayats from 04 to 08 in Diu District and has constituted Gram Sabhas for each newly created Gram Panchayat vide Notification No.BDO/DIU/GP-VNK/2022-23/52 and Notification No.BDO/DIU/GP-SAU/2022-23/58, both dated 16.01.2023;

And whereas, the Administrator, Dadra and Nagar Haveli and Daman and Diu, has also determined the total number of seats for each Gram Panchayat and the number of seats to be reserved for SCs, STs, Women belonging to SCs and STs and Women (General) in each Gram Panchayat in Diu District vide Notification No.BDO/DIU/GP-VNK/2022-23/179 dated 15.03.2023;

And whereas, Section 12 (4) of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012 (hereinafter called the said Regulation) states that each Gram Panchayat area shall be divided by the Election Commission into territorial constituencies in such manner that the ratio between the population of each constituency and the number of seats allotted to it shall, so far as practicable, be the same throughout the Gram Panchayat area;

And whereas, Rule 3 (1) of the Dadra and Nagar Haveli and Daman and Diu Panchayats (Election Procedure) Rules, 2023 (hereinafter called the said Rules) provides, inter-alia, that the Election Commission shall distribute the seats assigned to each Gram Panchayat and District Panchayat to single member territorial wards and delimit them on the basis of the latest census figures, having regard to certain provisions, namely, all wards shall, as far as practicable, be geographically compact areas, and in delimiting them regard shall be had to physical features, existing boundaries of administrative units, facilities of communication and public convenience;

And whereas, Rule 3 (2) of the said Rules provides as under :-

- (a) the Election Commission shall publish its proposals for the delimitation of wards in the Official Gazette and also in such other manner as it thinks fit, inviting objections and suggestions in this regard;

- (b) Specify a date by which objections and suggestions to the said proposal could be made;
- (c) Consider all objections and suggestions which may have been received by it by the date so specified under clause (b), and for the purpose of such consideration, hold one or more public meetings, if necessary, at such place or places as it thinks fit; and
- (d) thereafter, by one or more orders, determine the delimitation of Gram Panchayat wards;

Now, therefore, in exercise of powers conferred by sub-section (4) of Section 12 of the said Regulation read with Rule 3 (1) & (2) of the said Rules, the Election Commission for Dadra & Nagar Haveli and Daman & Diu, proposes to rationalize the boundaries of wards of six newly created Gram Panchayats i.e. Maharani Laxmibai Gram Panchayat, Vanakbara Gram Panchayat, Maharana Pratap Gram Panchayat, Saudwadi Gram Panchayat, Shaheed Bhagat Singh Gram Panchayat and Sardar Vallabhbhai Patel Gram Panchayat in Diu District of the UT of Dadra and Nagar Haveli and Daman and Diu on the basis of population ascertained by the UT Administration based on the 2011 Census figures and hereby publishes its proposal for the delimitation of wards of the above Gram Panchayats, as specified in the Annexure appended to this notification, for inviting suggestions and objections in this regard from all concerned by 2nd June, 2023.

Objection/suggestion to the above proposal, if any, should be submitted to any of the under mentioned officers between 10.00 a.m. and 4.00 p.m. on all working days not later than 2nd June, 2023:

- (1) The Collector, Diu, UT Administration of Dadra & Nagar Haveli and Daman & Diu, Collectorate, Diu
- (2) The Chief Executive Officer, District Panchayat, Diu

Any suggestion or objection received beyond the specified date and time shall not be considered.

For this purpose, detailed maps showing the extent of each ward of the aforesaid six Gram Panchayats shall remain available for inspection, free of cost, in the offices of the aforesaid officers.
