Whereas, it appears to the appropriate Government that a total of 338.00 Sq. Mtrs. (standard measurement) land is required in the Moti Daman, Daman District for public purpose, namely, the Acquisition of land for Construction of Protection Wall with Jampore Ghat for Extension of Jampore Sea Front upto Varliwad School at Jampore, Moti Daman. The details of the land/lands for the above said project in the Moti Daman of Daman District is enclosed herewith as Annexure – I. The Social Impact Assessment (SIA) was carried out by the SR Asia, Ghaziabad, Uttar Pradesh, an Agency appointed by the Dy. Collector (HQ) with the approval of the Land Acquisition Collector/Collector, Daman vide Order No.3/112/LND-ACQ/2022-23/5121 dated 29/12/2022 and a report submitted/ preliminary investigation was conducted by a team constituted by Collector as laid down under rule 4. The summary of the Social Impact Assessment Report/ preliminary investigation is as follows (copy attached):

The U.T. Administration of Dadra Nagar Havel and Daman & Diu has decided to extend the Jampore Sea front upto Varliwad School at Jampore, Moti Daman for length of 2.05 Km, with construction of diaphragm wall for sea protection, construction of sea front road from Jampore beach to Varliwad School, walkway on sea side, plantation along the road, electrical work, parking along the road with proper drainage system with precast U-shape drain and development of Ghat including other amenities Toilet Block with Shower room and Kiosk (Food court) and Musical Fountains to develop it as a tourist Spot, to develop the Jampore beach more tourist friendly.

In view of the above it is requested to consider the justification and initiate the process of proposed land acquisition for the Construction of Protection Wall with Jampore Ghat for Extension of Jampore Sea Front upto Varliwad School at Jampore, Moti Daman at the earliest please.

The land acquisition is recommended based on the popular demand of the locals and public representative while ensuring the following timely manner.

- 1. The project is based on the popular and local public demand and therefore is a matter of public interest.
 - 2. All the affected families are ready to give land for the projects.
 - 3. The SIMP plan need to be implemented in a timely manner.
- 4. The construction agency should ensure and control all type of negative impact that can have on the neighborhood.
- 5. The District Administration or authorities should look at all possible measures to minimize the impact due to the influx of the people from outside in the area which may result into traffic congestion, waste generation, law and order and social disharmony.
