# NOTICE INVITING OPEN BID RE-AUCTION (3rd CALL) FOR SALE OF CHICKOO FRUITS FOR 2023-24

A public **re-auction (3<sup>rd</sup> call)** for sale of Chickoo Fruits produced/ harvest at Govt. Seed Multiplication Farm, Kachigam, during the period w.e.f. 01/09/2023 to 30/06/2024, will be held on **17/08/2023 at 11.00 a.m.** at Farmer Training Center, Kachigam, Daman by the auction/harvest committee. Interested parties are requested to remain present at Farmer Training Center, Kachigam during the re-auction (3<sup>rd</sup> call) for bidding, subject to terms & conditions given below:

#### **TERMS AND CONDITIONS:-**

- 1. The upset price for the bid is **v** 2,76,500/- (Rupees Two Lakh Seventy Six Thousand Five Hundred Only) the intended bidder are required to bid above the upset price.
- 2. The re-auction ( $3^{rd}$  call) shall be held on open bid system. Interested bidder shall have to deposit a token amount of  $\overline{\mathbf{v}}$  5000/- (Rupees Five Thousand Only) in cash at a time of re-auction for taking part in it, the said amount shall be refunded back to unsuccessful bidder after the auction/bid.
- 3. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
- 4. The highest bidder has to pay full amount of bid through Cheque/ Demand Draft/ POS Machine/ Online Net Banking within three working days from the date of issue of letter regarding intimation of highest bidder for harvesting of Chickoo fruit otherwise their token amount of ₹ 5000/- (Rupees Five Thousand Only) will be for forfeited the Government and offer will be given to Second highest bidder.
- 5. Assigning of any tree or trees in the orchard to other parties and /or subletting of any trees to other parties by any mean, by the successful bidder will not be allowed under any circumstances.
- 6. The successful bidder will have to pay within 5 days from the date of demand an amount equal to 5% of the total value of the bid amount as Performance Guarantee in the form of FDR/ Demand Draft/ Cheque drawn in the favour of the **Director-cum-Deputy Secretary (Agriculture), Daman** form any Nationalized /Scheduled Bank valid upto a period one years from the date of issuing order.
- 7. The bidder should ensure that he has to follow all the guideline of Corona virus /Covid-19 and others issued by the Govt. of India/ U.T. Administration from time to time.
- 8. The Bidder is himself responsible for transportation of the harvested fruits from the farm through labours / vehicle including obtaining vehicle permission etc. from the competent authority.
- 9. The Bidders should submit the copy of Aadhar Card along with as an Address Proof.
- 10. The amount deposited against Performance Guarantee will be released only after successful completion of tenure granted to such bidder for harvesting of Chickoo Fruits after deducting dues payable to the Government, if any.
- 11. The Chickoo Orchard will be open for the inspection by the interested person(s) between 10:00 Hrs to 17:00 Hrs on any working days, however, with prior permission of the I/c of Govt Seed Multiplication Farm, Kachigam, Nani Daman. The I/c of Govt Seed Multiplication Farm, Kachigam, Nani Daman, has authority to deny such permission for the reasons not to be explained to the interested person(s).
- 12. No any kind of damage shall be caused to the trees and other property of the Farm. In case of any such damage found the successful bidder has to compensate the same as per instructions of the I/c of Govt. Seed Multiplication Farm, Kachigam, failing which, the bidder will not be allowed to continue the harvesting of Chickoo Fruits. The Government shall not be responsible for the damages occurred to the bidder on account of such discontinuation of harvesting. If required, his Performance Guarantee/EMD lying with the department will also be forfeited to the Government in order to recover the losses caused to Government.
- 13. Department will not be responsible/ compensated for any damage / loss cause to the successful bidder due to any natural calamity or accidental fire.
- 14. The harvesting /grading /transportation / sale of fruits is allowed on all working days during working hours till the end of harvest season at the responsibility & cost of successful bidder.
- 15. The right to accept or reject all bids, without assigning any reason thereof, is reserved with the Director-cum-Deputy Secretary (Agriculture)/Head of Office, Agriculture Department, Daman.
