In exercise of powers vested in him under Rule 18 of the Delegation of Financial Powers Rules, 1978, the Administrator, Dadra & Nagar Haveli and Daman & Diu is pleased to approve implementation of revision of Saraswati Vidya Yojana in UT of DNH&DD in supersession of all earlier notification issued in this regard as under:

- I. Name of Scheme: Saraswati Vidya Yojana
- II. Department:- Directorate of Education, Daman, UT of D&NHDD
- III. Introduction:-

The UT Administration of Dadra & Nagar Haveli and Daman & Diu has envisaged a 'Saraswati Vidya Yojana' for the girl students of UT of Dadra & Nagar Haveli and Daman & Diu. The scheme aims to encourage girl students to continue education keeping in view the aim of "Beti Bachao Beti Padhao".

#### IV. Objective:-

The objective of the scheme is to retain the girl students at Secondary & Higher Secondary stage and thereby decreasing the Dropout of the girl students by providing Bicycle to the girl students of class VIII to commute to school. The scheme also aims to provide financial assistance to girl students pursuing higher education in professional courses thereby reducing gender disparity in the society.

#### V. Target Beneficiaries/ Scope:-

- Girl students of class VIII of Government and Government Aided School of the UT of D&NH and DD are eligible for Component-I of the scheme (Free Distribution of Bicycles)
- Domiciled Girl Students pursuing Professional Courses are eligible for Component – II of the scheme. (Reimbursement of fees for Diploma/Graduation and Post-Graduation Professional Courses).

#### IX. Penalty Clause:-

If any applicant or beneficiary is found to be guilty of forgery of documents, false declaration, availing multiple scholarships, etc shall be penalized by way of recovery or shall face legal actions as deemed fit.

#### Component - I - Free Distribution of Bicycles

#### I. Salient features:-

The girl students of class VIII of Government and Government Aided Schools of this UT will be provided bicycle.

#### II. Procedure:-

- 1. The Head Master/ I/c Head Master will provide the number of enrolment of Girls in Std. VIII in Government and Government Aided Schools to the District Education Office.
- 2. Bicycles will be provided to schools at the time of commencement of the New Academic Year as per the requirement of the respective schools.
- 3. The Head Master/I/c Head Master shall be responsible for distribution of Bicycles.

#### III. Application Form and List of Documents:-

1. The girl student does not require to make any application individually.

#### IV. Special/ General Conditions/ Scheme Guidelines:-

- 1. The girl students once availed the benefit will not be provided with the same in any of the subsequent year.
- 2. Headmaster(s)/Principal(s) of Middle Schools/High Schools/Higher Secondary Schools shall hold the right to make necessary enquiry about the usage of the bicycles.
- 3. Directorate of Education and District Offices shall has the right to take legal action against the girl's parents, if the bicycle is found to be sold.

#### V. Timelines:-

1. Distribution of bicycles shall be carried out at the commencement of the Academic Year.

### Component - II - Reimbursement of Fees for Diploma/Graduation and Post-Graduation Professional Courses

#### I. Nature of Assistance/Benefit:-

- 1. 100% of Tuition Fee & Academic Fees will be reimbursed to girl students whose parental/Husband income is **below Rs.1.50 Lakh**.
- 2. 50% of Tuition Fee & Academic Fees will be reimbursed to girl students whose parental/Husband income is above Rs.1.50 Lakh.
- 3. Re-imbursement will be allowed subject to maximum of Rs.2.50 Lakhs (Rupees Two Lakh Fifty Thousand only) per year for girl students pursuing/pursued Diploma/Graduate Professional Courses and of Rs.3.50 Lakhs (Rupees Three Lakh Fifty Thousand only) per year for girl students pursuing/pursued Post Graduation Professional courses.
- 4. In case of academic session of 1.5 year, the re-imbursement will be allowed subject to maximum of Rs.3.75 Lakh (Rupees Three Lakh Seventy Five Thousand) per academic year for Graduate Professional courses and Rs. 5.25 Lakh (Rupees Five Lakh Twenty Five Thousand only) per academic year for Post-Graduation Professional courses.
- 5. An additional allowance of 50% of Hostel charges (excluding Mess Charges) with a capping of maximum Rs.30,000/-(Rupees Thirty Thousand) per year will be provided. The same is over and above the ceiling limit set above i.e. Rs.2.50 Lakhs/Rs.3.50 Lakhs, etc.

#### II. Eligibility Criteria:-

- 1. Parents/Husband of the girl student should be a domiciled resident of UT of Dadra & Nagar Haveli and Daman & Diu.
- 2. In case the father or the mother of the girl student is not alive, and the girl student is fully dependent and living with the Guardian, the Guardian should be a domiciled resident of UT of Dadra & Nagar Haveli and Daman & Diu.
- 3. The benefit will not be provided to those girl students who have failed in any annual/semester examination of that academic year for which the application has been made for reimbursement.
- 4. Father/husband/(in case married) of the student should be a domiciled resident of UT of Dadra & Nagar Haveli and Daman & Diu. (In case the father/husband is not alive mother/father in law/self should be a domiciled resident of this UT.) and the student should have studied continuously for Five Years in any of the High Schools/Higher Secondary Schools of the UT including the year of qualifying examination i.e. SSC/HSC examination.
- 5. Only First two Girl Child of the family will be eligible for the benefits under this scheme.

#### Exclusion:-

- 1. The Scheme will not cover the student pursuing education through correspondence or distance mode.
- 2. The benefit will not be provided to those girl students who have failed in any annual/semester examination of that academic year for which the reimbursement has been claimed.
- 3. The accommodation fees of the students staying as paying Guest or in a flat system shall not be reimbursed. Hostel accommodation availed in respective college hostel and private registered students/youth hostels will only be reimbursed.
- 4. This scheme shall not cover the students pursuing double graduation.

#### III. Special/ General Conditions/ Scheme Guidelines:-

- The reimbursement of Tuition and Academic Fees shall be given to girl students who are pursuing Diploma/Graduation/Post Graduation Professional courses in institutions/universities recognized by UGC, AICTE, MCI, DCI, PCI, NCERT, NCTE, Nursing Council of India, etc.
- 2. The fees will be reimbursed for the institutions whose fees is approved by the respective States/UT Government Fee Fixation Committee.
- 3. While calculating Tuition and Academic Fees, the fees such as Capitation Fee, Infrastructure Fee and Development Fee will not be considered.
- 4. In case the Hostel Charges are inclusive of Mess Charges and the same is not mentioned separately in Fee Receipt, the Hostel Charges will be considered as 50% amount of the total amount of the fee receipt with the capping of Rs. 30,000/- per Year. Therefore, 50% of the benefit of the considered 50% amount will be reimbursed.
- 5. Special Clause Secretary (Education) can recommend upto a maximum of 10 cases in a year (which may not fall in eligibility criteria) to a committee comprising of Advisor to Administrator, Secretary (Higher Education), and Secretary (Education) for getting benefits under this scheme.

#### Procedure for identification of beneficiaries:-

1. Application will be called from eligible applications by way of advertisement in local newspaper and website.

- 2. The Scrutiny Committee will scrutinize each application and supporting documents as per the eligibility criteria.
- 3. The Scrutiny process will also consist of spot visit/physical verification of Colleges/Hostel if need be.
- 4. The Scrutiny Committee shall confirm whether the College has necessary Government recognition/affiliation.
- 5. Upon Scrutiny of these applications, minutes of the meeting will be drawn and placed for approval.
- 6. The Scholarship will be disbursed after the approval of the Hon'ble Administrator, UT of D&NH and DD.

 Upon approval of the Competent Authority, the accounts section shall verify the bank details of the beneficiaries, generate bills on PFMS, and send the bills to P&A Office for disbursement.

#### V. Application Form and List of Documents to be attached:-

- 1. Original Fee Receipts.
- 2. Copy of Domicile Certificate of applicant as per clause II(4) above issued by Competent Authority of UT Administration D&NH and DD.
- 3. Copy of Income Certificate of the parent or Husband (in case married) issued by Competent Authority of UT Administration D&NH and DD in case of income below 1.50 lakhs.

- 4. Copy of the relevant order issued by concerned state with respect to Fee Fixation of the respective college/institute.
- 5. Copy Annual Exam/Semester result of the respective Academic Year for which claim for reimbursement of fees under the scheme is made.
- 6. Self attested copy of current year examination Marksheet.
- 7. Self-attested copy of Bonafide or Schooling Certificate stating Continuous last 05 years of study in UT Administration D&NH and DD.
- 8. Copy of Aadhar card.
- 9. Copy of Bank Pass book (Aadhar Seeded).
- 10. Declaration regarding availing benefit only under the Saraswati Vidya Yojana Scheme and that no claim is made in any of the other scheme for respective Academic Year for which the claim has been made.
- 11. Declaration from parents/guardian regarding application for reimbursement of fees not more than 02 girls' children of the family.

#### VI. Timelines:-

1. Applications shall be invited in the month of October for immediate previous (one) Academic Year.
