NOTIFICATION

In pursuance to the letter referred above, the **District Ujjwala Committees** are hereby constituted for Dadra & Nagar Haveli, Daman and Diu Districts respectively to oversee the implementation of the Pradhan Mantri Ujjwala Yojana (PMUY) and to ensure that only eligible households receive connections in the Districts of Dadra & Nagar Haveli, Daman and Diu. Composition of the committees is as follows:-

Sr. No.	Positions	Name/Designation
1	Chairman	District Collector or a Senior officer authorized by him.
2	Member Coordinator	District Nodal Officer, (from Oil Marketing Company* which has been assigned the district)
3	Member-1 and 2	Officer from the Oil Marketing Companies*
4	Member-3	District Food and Civil Supplies Officer
5	Member-4, 5 and 6	Non-Official Members**

* Oil Marketing Companies here means IOCL, BPCL & HPCL, Maharatna Public Sector Enterprises under the Ministry of Petroleum and Natural Gas,

** Non-official members will be as identified by the National Implementation Committee of the PM Vishwakarma Scheme under the MSME Ministry for districts where the committee has already been notified. For the rest of the districts, committee will co-opt non official members as and when they are identified by the National Implementation Committee of PM Vishwakarma Scheme.

Responsibilities of Committee are as under:

1. Monitoring of status of PMUY applications:

- a. The committee will scrutinize PMUY applications, review pendency and their disposal in the district.
- b. The committee will actively work to ensure timely releases and operationalization of PMUY connections.

2. Dissemination of Scheme details.

- a. The committee will exercise oversight on promoting awareness about the PMUY scheme.
- b. Periodic reports shall be submitted to the Committee regarding efforts made for increasing dissemination of the scheme and offtake.
- c. The committee will serve as a bridge among various departments involved in facilitating LPG connections to poor households.
