- 2. A person nominated as a member by virtue of an office shall cease to be member when he ceases to hold that office
- 3. A member shall not be paid any remuneration except travelling and daily allowance at the rate admissible to him in his respective Department and be paid from the source he draws salary and a member nominated under clause (f) of sub- paragraph (1) of paragraph 11 shall be paid travelling allowance or dearness allowance by General Insurance Council, at the rate as may be decided by the General Insurance Council.
- 4. Powers and functions of District Level Committee. The District Level Committee shall undertake all functions connected with the implementation of this scheme at the District Level, and it shall also perform the following functions, namely:
  - a) to evaluate the progress of implementation of this scheme in the concerned District and take corrective steps, wherever necessary:
  - b) to submit a report on quarterly basis to the Standing Committee, including in electronic form and the report shall, inter alia, include month-wise statistics about the claim applications received, awarded, pending and reasons for pendency:

- (ii) These shall apply to the posts specified in column-1 of the Schedule to these rules.
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.

#### 2. Number of Posts, Classification and Level in the Pay Matrix :-

The number of the post, classification of the said posts and the Level in the Pay Matrix attached there to shall be as specified in Column 2 to 4 of the Schedule to these rules.

Provided that, the Administrator of Dadra & Nagar Haveli and Daman & Diu may vary the number of posts in column 2 of the said Schedule from time to time subject to exigencies of work.

#### 3. Method of recruitment, age limit, qualifications etc:-

The method of recruitment to the said post, age limit, qualifications and other matters relating therewith shall be as specified in column 5 to 13 of the aforesaid Schedule.

#### 4. Disqualification:-

No person, (a) who has entered into or contracted a marriage with a person having a spouse

living or; (b) who having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service.

Provided that the Administrator of Dadra & Nagar Haveli and Daman & Diu, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

#### 5. Power to relax:-

Where the Administrator of Dadra & Nagar Haveli and Daman & Diu is of the opinion that it is necessary or expedient so to do, he may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

#### 6. Saving:

Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes, and the other special categories or persons in accordance with the orders issued by the Central Government from time to time in this regard.

#### AWARD

(Passed on 13/09/2023)

- 1) A reference is received from Joint Secretary (Lab & Emp.), Daman vide his order dated 02.09.2013 under Section 10 (1) (d) of Industrial Dispute Act (here-in-after referred to as 'IT Act') in terms that whether charter of demand submitted employees of first party is testified, if yes, to what extent and what relief second party workmen are entitled to, and whether demand of second party-workmen for VRS amounting Rs.7 lakhs is justified, if yes, what extent.
- 2) Second party has filed the statement of claim. Thereafter, first party appeared and filed their written statement. The issues were by the tribunal. Further, second party has also adduced oral evidence. However, pending the reference subsequently both parties have arrived to a settlement and filed a consent term Ex.62. As per the consent term the first the party agree to pay the amount as per the annexure A. the second party - workmen except Rajendra Prasad Meta, Chandrakumar Singh and Anupkumar Patel present before this tribunal and on explanation of the contents of the consent term agreed for it. Moreover, it could be seen that the total amount agreed to pay by first party is more than Rs.7 lakh which are the subject matter of the reference. Therefore, in respect of the workmen present before this tribunal, the consent term has to be accepted. The Chandrakant Patel and Hitesh Bhandari filed affidavit Ex.64 and 65 respectively stating that there is no contact of Rajendra Prasad Meta, Chandrakumar Singh and Anupkumar Patel since long. Further, pursis Ex.66 is filed by first party that they undertake to pay those workmen the amount in the same ratio in which payment is made to other 14 workmen as per the list Annexure - A to Consent Term Ex.62. Both Ld. advocate for first party as well second party submitted that these workmen are not in contact since long. The consent term Ex.62 and pursis Ex.66 is filed by Adv. Shri. S.S. Bhatt as an duly authorized by first party company for which a authority letter is annexed. As the amount paid to 14 workmen and agreed to pay remaining three workmen to the same proportionate is more than the amount referred in the reference, hence as the first party undertake to pay also remaining 3 workmen or their legal heirs, it is not proper to keep the reference pending as those three workmen are not coming forward and not known whereabout of them

to other second party workmen and first party company. Thus, the reference is to be disposed off in terms of consent terms Ex.62 and pursis Ex.66. Accordingly, I pass following order.

#### ORDER

- 1. IDR No. 11/2013 is hereby answered in terms of consent terms Ex.62 and pursis Ex.66 and accordingly, disposed off.
- 2. The copy of the award be sent to the Joint Secretary (Lab & Emp.), Daman for publication.
