Administration of Dadra & Nagar Haveli and Daman & Diu hereby requests to all stakeholders to go through the aforesaid proposed draft Amendment of Recruitment Rules and furnish their comments/suggestions (if any) to the undersigned within a period of 30 days with effect from 23/11/2023 to 22/12/2023. Thereafter, Directorate of Education (Higher & Technical) will rectify the aforesaid proposed amendment in the draft Recruitment Rules only.

5. In case, no comments/suggestions received within 30 days from issuance of the said O.M., the Directorate of Education (Higher &Technical), U.T. The Ph.D: degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

<u>Note-1</u>): - The Academic score as specified in Appendix II (Table 3A) for Universities, and Appendix II (Table3B) for Colleges, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

<u>Note-2</u>): - If a Class/ Division is not awarded, minimum of 60% marks in aggregate shall be considered equivalent to first class/ division. If a Grade Point System is adopted the Cumulative Grade Point Average will be converted into equivalent marks as below: -
