AS per Rule 4(1) of Notaries Rules, 1956, a person may make an application (in original) for appointment as a notary (hereinafter called "the applicant"). The application shall be sent by RPAD/Courier/By Hand so as to reach on or before 5:00 P.M. on 03/02/2024.

Form-I meant for those Advocates who have -

- (a) Practice experience of at least for 10 years i.e. 10 years' experience from the date of the enrolment in the concerned Bar Council.
- (b) Practice experience of at least for 7 years for those belonging to Scheduled Castes/Scheduled Tribes/Other Backward Classes/Woman/a person with benchmark disability as defined in clause(r) of Section-2 of the Rights of Persons with Disabilities Act, 2016 (49 of 2016) i.e. 07 years' experience from the date of the enrolment in the concerned Bar Council.

Form-II is meant for those Retired Government Officers who had been-

- a) A member of the India Legal Services under the Central Government, or
- b) He had been at least for 10 years, -
 - (i) A member of Judicial Services; or
 - (ii) Held an office under the Central Government or a State Government requiring special knowledge of law after enrolment as an Advocate; or
 - (iii) Held an office in the department of Judge Advocate General or in the legal department of the armed forces.

DOCUMENTS TO BE ATTACHED WITH THE APPLICATION FORM: -

- (i) An Attested copy of Proof pertaining to date of birth, copy of Matriculation Certificate, copy of Aadhar and PAN Card.
- (ii) An Attested copy of original Graduation Degree Certificate.
- (iii) An Attested copy of original Law Degree Certificate.
- (iv) An Attested copy of the Original Enrolment Certificate issued by the Bar Council.

- (v) Experience certificate from the concerned District Judge or Presiding Officer of the court or Tribunal where the applicant practices as an Advocate.
- (vi) Name in the application form should be same as that in the Enrolment Certificate issued from the Bar Council, if any Advocates want to change his/her name, generally in case of Women after marriage he/she has to change his/her name in the Enrolment Certificate also;
- (vii) Marriage Women Advocates should attach an attested copy of the Marriage Certificate.
- (viii) Disability Certificate on the prescribed format in case of a person with benchmark disability.

Note:

- i. The Advocates whose certificate of practice as a Notary is in force, their certificate will remain in force only till the completion of fresh recruitment process. However, they are at liberty to apply for Fresh Appointment of Notary through this Advertisement.
- ii. The Advocates who have applied for the Notary for the first time, their application will not be processed further and they have to apply a fresh for the Notary through this Advertisement.
- iii. Advocates, whose names have not been recommended by the Interview Board earlier, may apply fresh.
