TERMS & CONDITIONS

- 1. The public auction of "Miscellaneous Industrial items" shall be carried out under the supervision of the committee consisting of the Deputy Collector (H.Q.), Daman, the Deputy Collector (Gen.), Daman, the Mamlatdar, Daman, the Labour Inspector, Daman, and Accountant of the Collectorate, Daman on 14/02/2024 at 11:00 A.M. at land bearing Survey No.56, Government Industrial Zone, Dunetha, Bhenslore, Nani Daman, District Daman.
- 2. The interested bidder shall have to deposit a token amount of Rs.5,000/- at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
- 3. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
- 4. The auction value shall be selected on the basis of items offered by the highest bidder.
- 5. As it is not possible to bid the items individually, therefore the items in bulk shall be bid. The value of the items in bulk shall be the value offered by the highest bidder during the time of auction.
- 6. The successful bidder shall have to lift the auctioned "Miscellaneous Industrial items" within same day from the date of finalization of the auction and after payment of full amount after which this office shall not be responsible for their safe custody. The successful bidder has to bear whole charge their own for lifting of auction materials.
- 7. The interested parties should inspect the "Miscellaneous Industrial items" and satisfy themselves about their conditions. No complaint whatsoever will be entertained after the public auction is submitted or before or after the materials are lifted.
- 8. The bid shall be considered as final only after approval of the Committee and its decision as regards to any dispute arising in the course of the auction shall be final and binding on all the persons participating in the auction.
- 9. Right to accept or reject any bid or all the bids without assigning any reason is reserved by the process of bidding.
