Executive Engineer, OI DC Ltd., invites item rate **e-tender** in two bid system on behalf of OI DC Ltd., from Eligible contractors/ Agencies registered under appropriate class i.e. Category 'C'/Class II and above for composite work and civil/electrical/E&M services/Horticulture work & above with CPWD/ State PWD/ MES /Railways and who have carried out similar nature of works in Govt./Private sector and meeting the minimum Pre-qualification criteria. 1. Minimum Eligibility Criteria:

- Only one bid per bidder is permitted.
- No Joint venture/Consortium permitted for bidding.

2. Minimum Qualification Criteria:

Turn Over: To qualify for award of the contract, each bidder should have achieved an average annual **financial turnover landscaping works of at least 50%** of the estimated cost during the immediate last 3 consecutive financial years ending 31st March 2023.

3. (i) Experience of Similar Works:

Similar work means: The bidder should have completed the Landscape work of an Institutional/Industrial/Commercial campus.

The Bidder should have satisfactorily completed similar works during last 7 (Seven) years on the last day of the month previous to the one in which the tenders are invited.

- a) Three similar works costing equal to 40% of the estimated cost. **OR**
- b) Two similar works costing equal to 60% of the estimated cost. **OR**
- c) One similar works costing equal to 80% of the estimated cost.

The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to previous day of last date of submission of tender.

4. Bidder should not have incurred any loss (profit after tax should be positive) in more than two years during the last five consecutive balance sheets, duly certified and audited by the Chartered Accountant.
 - 1) Solvency of the amount equal to 40% of the estimated cost of the work is required to be provided by the bidder.
 - 2) If any clarifications are required, regarding the bidding document the same can be obtained from the Executive Engineer, OI DC Ltd. DD&DNH on any working days during the tender period, in written via email on oidcdnh@yahoo.in
 - 3) Other details can be seen in the bidding documents.
 - 4) All necessary documents shall be submitted online and in hard copy. It is compulsory to submit the original Tender fee in the form of DD and EMD in the form of FDR & Bank Guarantee in online and hard copy.
 - 5) Conditional bid will not be accepted.
 - 6) The intending bidder must read the terms and conditions of **CPWD-6** carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.

The Bidder who should have appropriate i.e. Category 'C'/Class II for composite work & above class registration, subject to fulfilling the other terms and conditions of the contract i.e. Similar nature of works, Turnover, Solvency, etc. Non submission of a valid registration shall make the bid non responsive and the bid shall be rejected.

5. The Financial Bid should be submitted online only. The submission of financial bid in hard copy shall make the bid non-responsive and the bid shall be rejected.

OI DC reserves the right to reject any or all tenders without assigning any reason and the selection shall be at the absolute discretion of the Corporation and Corporation's decision in this respect shall be final and binding.
