The bidder must submit a copy of their PAN Card Number, AERB Registration certificate, residential proof i.e. Ration Card, Voter ID Card etc along with Rs.1000/- refundable auction fees without which no bid will be entertained.

The auction fees of Rs.1000/- shall be held refunded back to the unsuccessful bidder after the auction. The successful bidder will have to pay deposit 50% deposit of the offered bid on the spot.

The bid offered should be a minimum Rs. 2000/- (Rupees Two thousand only) above the upset price.

An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three times uninterrupted.
