The Child Welfare Committee will also have the following Roles & Responsibilities:

The said Child Welfare Committees will exercise such powers and discharge such duties as conferred on such committees under the Juvenile Justice (Care and Protection of Children) Act, 2015.

As per Section 27 (9) of the Juvenile Justice (Care and Protection of Children) Act, 2015, the Child Welfare Committees shall function as a Bench and shall have the powers conferred by the code of Criminal Procedure, 1973 on a Metropolitan Magistrate or, as the case may be, a Judicial Magistrate of First Class.

The Child Welfare Committees shall meet on at least 10 (Ten days) in a month for minimum 06 hours and shall observe such rules and procedures with regard to the transaction of business at its meetings, as may be prescribed in section 28(1) of the Juvenile Justice (Care & Protection of Children) Act, 2015.

The Child Welfare Committees will exercise the power as per provision mentioned under Section 28, 29, 30 of the Juvenile Justice (Care & protection of Children) Act, 2015, and as per Rule 15, 16, 17 of the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.

No person shall be appointed for a period of more than three years as the member of the Committee.

The appointment of chairperson and members of the Child Welfare Committees may be terminated after making an inquiry by the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu, if Chairperson/Member become ineligible under Sub section 7 of the Section 27 of the Juvenile Justice (Care & Protection of Children) Act, 2015.
