NOTIFICATION

Whereas, the use of Aadhar as an identity document for delivery of services or benefits or subsidies simplifies the Government delivery processes, brings in transparency and efficiency and enables beneficiaries to get their entitlements directly in a convenient and seamless manner by obviating the need to produce multiple documents to prove one's identity:

And whereas, the **Directorate of Medical & Health Services**(hereinafter referred to as the Department) is administering the scheme namely “**Dikri Development Scheme**” (hereinafter referred to as the Scheme)**notified on 05.03.2021, to provide financial benefits to the girls on attaining the age of 18**, which is being implemented through the **Directorate of Medical & Health Services** (hereinafter referred to as the implementing Agency(ies));

And whereas, under the Scheme, **LIC of sum amount of Rs. 42,372/- (Rupees Forty-Two Thousand Three Hundred Seventy-Two Only) (inclusive of all taxes) is purchase from Life Insurance Corporation named as Single Premium Endowment Plan (No. 917)** (hereinafter referred to as the benefit) is given to the **mothers in r/o. their girl child** (hereinafter referred to as the beneficiaries), by the implementing Agency as per the extant Scheme guidelines;

And whereas, the aforesaid Scheme involves recurring expenditure incurred from the Consolidated Fund of U.T. Administration of Dadra & Nagar Haveli & Daman & Diu;

Now, therefore, in pursuance of Section 7 of the Aadhar (Targeted Delivery of Financial and Other Subsidies, Benefits and Services) Act, 2016 (18 of 2016) (hereinafter referred to as the said Act), the government of UT of Dadra & Nagar haveli & Daman & Diu, hereby notifies the following, namely:-

1. (1) An individual eligible for receiving the benefits under the Scheme shall hereby be required to furnish proof of possession of the Aadhar number or undergo Aadhaar authentication.
- (2) Any individual desirous of availing benefits under the Scheme, who does not possess the Aadhar Number or, has not yet enrolled for Aadhaar, shall be required to make application for Aadhaar enrolment before registering for the scheme provided that he is entitled to obtain Aadhaar as per the Section 3 of the said Act, and such individuals shall visit any Aadhaar Enrolment Centre (list available at the Unique Identification Authority of India (UIDAI) website www.uidai.gov.in) to get enrolled for Aadhar.

(3) As per Regulation 12 of the Aadhaar (Enrolment and Update) Regulations, 2016, the Department through its implementing Agency, is required to offer Aadhaar enrolment facilities for the beneficiaries who are not yet enrolled for Aadhaar and in case there is no Aadhaar Enrolment Centre located in the respective Block or Taluka or Tehsil, the Department through its implementing Agency shall provide Aadhaar enrolment facilities at convenient locations in coordination with the existing Registrars of UIDAI or by becoming a UIDAI Registrar themselves:

Provided that till the time Aadhaar is assigned to the individual, benefits under the Scheme shall be given to such individual, subject to the production of the following documents, namely:-

(a) If he has enrolled, his Aadhaar Enrolment Identification Slip; and

(b) Any one of the following documents, namely:-

- a. Bank or Post Office Passbook with Photo; or
- b. Permanent Account Number (PAN) Card; or
- c. Passport, or
- d. Ration Card; or
- e. Voter Identity Card; or
- f. MGNREGA Card; or
- g. Kisan Photo passbook; or
- h. Driving license issued by the Licensing Authority under the Motor Vehicles Act, 1988 (59 of 1988); or
- i. Certificate of identity having photo of such person issued by a Gazetted Officer or a Tehsildar on an official letter head; or
- j. Any other document as specified by the Department:

Provided further that the above documents may be checked by an officer specifically designated by the Department for that purpose.

2. In order to provide benefits to the beneficiaries under the Scheme conveniently, the Department through its implementing Agency shall make all the required arrangements to ensure that wide publicity through media shall be given to the beneficiaries to make them aware of the said requirement.
3. In allcases, where Aadhaar authentication fails due to poor biometrics of the beneficiaries or due to any other reason, the following remedial mechanisms shall be adopted, namely:-
 - a. In case of poor fingerprint quality, iris scan or face authentication facility shall be adopted for authentication, thereby the Department through its implementing Agency shall make

provisions for iris scanners or face authentication along with finger-print authentication for delivery of benefits in seamless manner;

- b. In case the biometric authentication through fingerprints or iris scan or face authentication is not successful, wherever feasible and admissible authentication by Aadhaar One Time Password or Time-based One-Time Password with limited time validity, as the case may be, shall be offered;
 - c. In all other cases where biometric or Aadhaar One Time Password (OTP) or Time-based One-Time Password authentication is not possible, benefits under the scheme may be given on the basis of physical Aadhaar letter whose authenticity can be verified through the Quick Response (QR) code printed on the Aadhaar letter and the necessary arrangement of QR code reader shall be provided at the convenient locations by the Department through its implementing Agency.
4. In addition to the above, in order to ensure that no bonafide beneficiary under the scheme is deprived of his due benefits, the Department through its Implementing Agency shall follow the exception handling mechanisms as outlined in the Office Memorandum of DBT Mission, Cabinet Secretariat, Government of India dated 19th December 2017.

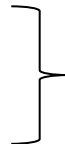

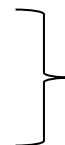

AWARD

(Delivered on 6th Day of January, 2024)

The Appropriate Government Administration of Daman and Diu, U.T., Daman was of the opinion that, an industrial dispute exists between the First party and Second party in respect of the termination of service of the second party by the management of the first party. Therefore in exercise of the power conferred by clause 'C' of Sub Section 1 of section 10 of the Industrial Dispute Act-1947, the Appropriate Government has referred this industrial dispute for adjudication to this Labour Court of Daman, vide letter bearing No.LE/LI/DMN/FACT-168/2020/322, dated 25/09/2020, which is received by this Court on 03/10/2020. Accordingly notices were issued to both the parties as per procedure prescribed under section 11 of the Industrial Dispute Act 1947. In response to the notices both the parties appeared before this Court. The second party has submitted statement of claim at Exh.5. The first party has filed reply at Exh.7.

(2) By way of statement of claim the Second Party alleged that, he has been in the service of first party at its manufacturing facility in Daman as a Helper w.e.f. 10/08/2008. He took leave for one month from 07/04/2019, but could not resume duty on expiry of leave due to some family dispute and back home at his native place. He had telephonically informed HR Manager of the management regarding his inability to resume duty on time. In the month of July, 2019, he returned from his native place and visited company to resume his duties. However, first party has denied resumption of his duty, even he was not allowed to enter company premises. During next three months, the second party reported for his duty repeatedly, but he has not been allowed to resume duty.

(3) On 03/10/2019, he has been informed that his service has been terminated. No charges were framed against the second party nor any allegations were formed by first party against him. The second party had been terminated illegally, improper, malafide and arbitrary and very harsh punishment. Hence, prayed for his reinstatement and back wages.

(4) The first party filed reply Exh.7 to statement of claim and denied the averments made in claim in toto. The first party submitted that the second party did not report for duties on the expiry of his leave and overstayed on leave. He has not intimated the first party company regarding overstaying of leave. However, the first party has sent intimation dated 30/07/2019 to second party, which has not been responded by him. Second party has remained absent without leave for 94.5 days during the period from April 2018 to March 2019. The second party is not legally entitled to claim any relief. Therefore, this reference deserves to be rejected.

I.D.R.No.06/2020

(5) Following points arise for determination. My findings on the said points are mentioned against each point for the reasons given below.

Points	Finding
1. Whether the claimant is illegally terminated from his service by the respondent?In the Negative.
2. Whether claimant is entitled for reinstatement with continuation of service and with full back wages?In the Negative.
3. What order and award? As per final order.

REASON

Point No. 1 to 3:-

(6) Second party has alleged that he was illegally terminated from his service by first party company. The first party appeared and resisted the claim before conciliation and offer to pay the dues of Rs. 28,333/- to the second party as a settlement amount. But the second party refused to accept the said offer. However, second party failed to lead evidence. Therefore, evidence of second party has been closed vide order dated 16/09/2023. Moreover, second party has failed to substantiate his claim. The second party has not adduced any evidence. Therefore, I answer the point Nos. 1 and 2 in the negative and accordingly reference is liable to be disposed off. In the result of point No. 3, I proceed to pass the following order.

ORDER

(1) The reference is answered in the negative.

(2) An award be submitted to the appropriate Government for it's publication as per section 17 of the Industrial Dispute Act, 1947.

As the road is passing through a university as well as hospital, this will enable the patient and students to commute to this area easily without much congestion.

The total area being Acquired for the proposed project is 30799 Sq.mtrs Sayli Village of Dadra and Nagar Haveli from SSR Collage to Canal Junction and Sayli outpost to Canal Junction.
