NOTIFICATION

The following draft rules which are proposed to be made by the Hon'ble Administrator of Dadra & Nagar Haveli and Daman & Diu, in exercise of power conferred by Section 65, 211 of Motor Vehicles Act, 1988 (Central Act No. 59 of 1988) (hereinafter referred to as the said Act) and as amended by Act 54 of 1994 and of all other powers enabling it in this behalf, are hereby published as required by sub section (1) of Section 212 of the said Act, for information of the persons likely to be affected thereby and notice is hereby given that the said draft rules will be taken into consideration by the Government on the expiry of fifteen days from the date of publication of this Notification in the Official Gazette.

All objections and suggestions to the draft rules may be forwarded to the Director-cum-Joint Secretary (Transport), RTO Complex, Airport Road, Nani Daman – 396210 before the expiry of fifteen days from the date of publication of the Notification in the Official Gazette.

Draft Rules

In exercise of the powers conferred by Section 65 of Motor Vehicles Act, 1988 (Central Act 59 of 1988) and as amended by Act No. 54 of 1994, the Administrator of Dadra & Nagar Haveli and Daman & Diu is pleased to amend the Daman & Diu Motor Vehicles Rules, 1989 as follows:

- 1. Short title and commencement:
 - (1) These Rules may be called the Dadra and Nagar Haveli and Daman and Diu choice Registration Number Rules, 2024.
 - (2) They shall come into force at once.
- 2. On and from the commencement of the Dadra and Nagar Haveli and Daman and Diu Choice Registration Number Rules, 2024, the rules related to the levy of fee for assignment of registration marks at the choice of the applicant in the Union Territory of Dadra and Nagar Haveli and Daman and Diu shall be substituted as below:
 - a) Non-Transport Vehicles:-
 - (i) The assignment of registration mark as specified in column (1) of the Schedule I, in any available series of registration marks shall be made available only on payment of additional fee to the highest bidder selected as per mode of allotment mentioned in the rule in respect of category 1, 2, 3, 4, 5, 6 & 7 in respect of all the Non-Transport Vehicles.
 - (ii) The retention of existing registration marks on purchase of new non-transport four wheeled vehicles or two wheeled vehicles shall be allowed only on payment of fee specified under Column (3) of Part (B) of Schedule I. Provided that the Retention of registration mark shall be allowed only if the registration mark has remained registered in the name of the applicant for a minimum period of three years, as on the date of application for retention.
 - b) <u>Transport Vehicles</u>:- The assignment of registration mark as specified in column (1) of the Schedule II, in any available series of registration marks shall be made available only on payment of additional fee to the highest bidder selected through e-auction as per mode of allotment mention in respect of category 1 & 2 in respect of all the Transport Vehicles.
 - c) The auction where applicable shall be conducted through e-auction on VAHAN portal or any other online system developed by the Department of Transport, UT Administration of Dadra & Nagar Haveli and Daman & Diu.
 - d) The Registration Numbers for vehicles belonging to the Government or Semi-Government or Government Undertaking shall be allocated irrespective of class or series i.e. Two-Wheeler / Light Motor Vehicles / Transport Vehicles from the open series. The Registering Authority will exercise the authority to allot these numbers.
 - e) The registration number under these rules shall be allotted only from the prevailing series in the jurisdiction of the concerned Registering Authority, subject to the availability. No request for allotment of registration number from a series not yet opened shall be entertained.
 - f) Registration Numbers so allotted under these rules will be non-transferrable.
 - g) The fees paid for the participation for the auction will be not be refundable.
 - h) The decision of the Registering Authority as regards issue of Choice Registration Numbers and auction shall be final.

- i) The Secretary (Transport), Dadra & Nagar Haveli and Daman shall be the Competent Authority for issuing approval for opening of new series and for issuing instructions and clarification of auction regarding implementation of the rule.
- j) The opened series for LMV will be for No 0001 to 9999 & series opened for Motor cycle & Transport Vehicle 01 to 9000(9999) for Motor cycle and 9001 to 9998 for Transport Vehicles
- 3. On and from the commencement of the Dadra and Nagar Haveli and Daman and Diu Choice Registration Number Rules, 2024 -
 - the provisions of Rule 58A of the Dadra & Nagar Haveli Motor Vehicles Rules, 1991 shall not be applicable to the Dadra and Nagar Haveli.
 - ii. the provisions of Rule 315 of the Daman & Diu Motor Vehicles Rules, 1989 shall not be applicable to the Daman and Diu.
 - iii. These Rules shall supersede all the earlier orders or instructions issued in this behalf. It is also further clarified that no circular or administrative order shall have precedence under the provisions of these Rules.
