The Child Welfare Committee will also have the following Roles & Responsibilities.

The said Child Welfare Committees will exercise such powers and discharge such duties as conferred on such committees under the Juvenile Justice (Care and Protection of Children) Act, 2015.

As per Section 27 (9) of the Juvenile Justice (Care and Protection of Children) Act, 2015, the Child Welfare Committees shall function as a Bench and shall have the powers conferred by the code of Criminal Procedure, 1973 on a Metropolitan Magistrate or, as the case may be, a Judicial Magistrate of First Class.

The Child Welfare Committees shall meet on at least 10 (Ten days) in a month for minimum 06 hours and shall observe such rules and procedures with regard to the transaction of business at its

meetings, as may be prescribed in section 28 (1) of the Juvenile Justice (Care & Protection of Children) Act, 2015.

The Child Welfare Committees will exercise the power as per provision mentioned under Section 28, 29, 30 of the Juvenile Justice (Care & protection of Children) Act, 2015, and as per Rule 15, 16, 17 of the Juvenile Justice (Care & Protection of Children) Model Rules, 2016.

No person shall be appointed for a period of more than three years as the member of the Committee.

The appointment of chairperson and members of the Child Welfare Committees may be terminated after making an inquiry by the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu, if Chairperson/Member become ineligible under Sub section 7 of the Section 27 of the Juvenile Justice (Care & Protection of Children) Act, 2015.

**DECLARATION**

WHEREAS, vide Preliminary Notification No. LAQ/ Sportscomplex/ Sayli/ 65/ 2021/ 170 dated 17.03.2023, it was Notified under section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule hereto (hereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for **Construction of Athletic Running Track at Sayli sports complex.**

WHEREAS, as required under sub section (2) of section 15 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, 1 objections were received by the Department, and a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu to proceed with the acquisition process and the same has been approved by the Appropriate Government i.e. Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu.

WHEREAS, the Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu is satisfied, on the basis of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the Rehabilitation and Resettlement Scheme shall be applicable because there are families getting affected due to the proposed acquisition.

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said lands are required for the public purpose, namely for Construction of Athletic Running Track at Sayli sports complex.

The Lands Statement and Plan can be inspected in the Office of the Collector, Dadra and Nagar Haveli, Silvassa during the Office hours.
