Sealed tender are hereby invited from the interested parties up to 11:30 AM on 10/06/2024 at for harvesting/ sale of Mango fruits in the Government Seed Multiplication Farm, Kachigam, Nani Daman, during the harvesting season for the year 2024-25.

**TERMS AND CONDITIONS:-**

1. The upset price for the bid is **Rs. 12,000/- (Rupees Twelve Thousand Only)** the intended Bidders are required to bid above the upset price.
2. The Bid/Tender shall be submitted as per Tender form (as enclosed) and submitted in the name of Director-cum-Joint Secretary(Agriculture), Agriculture Office, Fort area, Moti Daman in a sealed cover super scribed as **"Tender for sale of Mango Fruits 2024-25."**
3. The Mango Orchard will be open for the inspection to the interested person(s) between 10:00 Hrs to 17:00 Hrs on any working day with prior permission of the I/c of Govt. Agriculture Farm, Kachigam, Nani Daman. The I/c of Govt. Agriculture Farm, Kachigam, Nani Daman has authority to deny such permission for the reasons not to be explained to the interested person(s).
4. No any kind of damage shall be caused to the trees and other property of the Farm. In case of any such damage, the successful bidder has to compensate the same as per instructions of the I/c of Govt. Agriculture Farm, Kachigam, Nani Daman failing which, the bidder will not be allowed to continue the harvesting of Mango Fruits. The Government shall not be responsible for the damages occurred to the Bidders on account of the discontinuation of harvesting. If required, his EMD lying with Department will also be forfeited to the Government in order to recover the losses occurred to Government.
5. The bidder is himself responsible for transport the harvested fruits from farm through labours / vehicle including obtaining vehicle permission etc. from the competent authority.
6. The bidders should submit the copy of the Aadhaar Card alongwith copy of Address Proof.
7. The bidder should enclose EMD of **₹. 1500/- (Rupees One Thousand Five Hundred Only)** in the form of FDR/ Demand Draft/ Cheque drawn in the favour of the Director of Agriculture, Daman of any Nationalized /Scheduled Bank. Quotation submitted without EMD shall be summarily rejected.
8. The highest Bidder has to pay full amount of bid through Cheque / Demand Draft/ POS machine etc. within five working days from the date of issue of letter regarding intimation of highest bidder for harvesting of Mango fruit otherwise the tender will be rejected and the EMD will be forfeited to the Government and may be offered to Second highest bidder.

The successful bidder will have to pay within 3 days from the date of demand an amount equal to 10% of the total value of the bid amount as Performance Guarantee in the form of FDR/ Demand Draft/ Cheque drawn in the favour of the Director-cum-Joint Secretary (Agriculture), Daman for any Nationalized /Scheduled Bank valid up to the period of Six months from date of issuing order.
10. Department will not be responsible/ compensate for any damage / loss cause to the successful bidder due to any natural calamity or accidental fire.
11. The harvesting /grading /transportation / sale of fruits is allowed on all working days during working hours till the end of harvest season at the responsibility & cost of successful bidder.
12. The Bidder should ensure that harvesting of Mango fruit should be completed within **1 (One)** months from the date of issue of authority letter of harvesting Mango fruit.
