a. A tender evaluation committee will evaluate the technical as well as financial bids on last date of submission and the below evaluation process

shall be carried for each event. The technical bids of all Tenderers will be opened first.

b. The following evaluation criteria shall be used for each event separately.

The technical evaluation will carry a weightage of total 100 marks which will include the presentation of the bidder for the work of Execution of Yoga IEC & Main Event related supplies for International Yoga Day 2024 Celebration in Daman. After analysis of Technical Bids and presentation, the financial bids will be opened of the bidders scoring minimum 70 marks.

The financial score will be calculated as per the formula mentioned

Combined Technical and Financial Score (CTFS) with Weightage 70:30 will be
