ORDER

(UNDER SECTION 144 OF CRIMINAL CODE PROCEDURE, 1973)

WHEREAS, a large number of tourists and foreigners who are visiting to Daman District including the local public and fishermen are venturing into the sea at all the beaches of Daman District for swimming, bathing, fishing, and taking selfies;

AND WHEREAS, there have been reports of cases of the drowning of tourists in the sea while swimming, bathing, and taking selfies at the beaches of Daman District;

AND WHEREAS, due to the ongoing monsoon season, the sea is rough and risky and there is a possibility of the loss of human life to the tourists, local public, and fishermen if they are allowed to swim, bath, fish, and take selfies at all the beaches of Daman District;

NOW, THEREFORE, in the exercise of the power vested under Section 144 of Code of Criminal Procedure, 1973, (No. 2 of 1974), I, PRIYANSHU SINGH, SUB DIVISIONAL MAGISTRATE, DAMAN do hereby order that no tourists, local public and fishermen are allowed to venture into the Sea to swim, bath, fish and take selfies at all the beaches of Daman District to prevent the incidents of drowning that endanger to the human life.

This order shall come into force with immediate effect from $\underline{26/06/2024}$ to $\underline{31/08/2024}$.

Any person contravening this order shall be punishable under section 188 and other relevant sections of the Indian Penal Code, 1860.
