TERM & CONDITIONS

1. The public auction of Condemnation of Vehicles bearing Registration No. DD-03-W-0018, Maruti Suzuki SX 4 of the office of the Civil Judge (S.D) & Chief Judicial Magistrate, Daman shall be carried out under the supervision of the committee consisting of the Civil Judge (S.D) & Chief Judicial Magistrate, Daman and Civil Judge (J.D) & Judicial Magistrate (F.C), Daman on 25/09/2024 at 10:30 am.
2. The interest bidder shall have to deposit a token amount of Rs. 10,000/- Demand Draft in the name of "Civil Judge (S.D) & C.J.M., Daman" at the time of auction for taking part in it. The said amount shall be refunded back to the unsuccessful bidder after the auction. The successful bidder has to deposit 10% of the offered bid on the spot.
3. The bidder shall pay the amount of Rs.500/- has registration fee to take part in auction.
4. An offer shall be considered as highest and final only if the amount of bid offered by the bidder is announced consequently three time uninterrupted.
5. The sale will be subject to reserved and upset price of Rs.1,00,000/-.
6. The successful bidder shall deposit remaining part consideration amount within 48 hours. i.e. on or before 30/09/2024.
7. In default to pay entire bid/auction amount within 48 hours. The committee will have right to forfeit the token & advance amount without any notice and intimation.
8. The successful bidder is entitle for set off of amount deposited in form of Token amount and advance amount from entire auction amount.

The successful bidder shall have to pay full amount in the form of Demand Draft of final bid & lift the auctioned Vehicles within seven days from the date of finalization of the auction after which this office shall not be responsible for their safe custody and also vehicle will only be handover to successful bidder after R.T.O registration in his/her name on his own cost.
10. The interested parties should inspect the vehicles and satisfy themselves about their conditions etc. during officer hours from 10:30 am to 05:00 pm upto 24/09/2024.
11. The bid shall be considered as final only after approval of the Committee and its decision as regards to any dispute arising in the course of the auction shall be final and binding on all the persons participating in the auction.
12. Right to accept or reject any bid or all the bids without assigning any reason is reserved by the Committee.
13. The bidder must submit ID proof documents such as Pan Card, Aadhar Card and Votor ID etc. duly for taking part in the process of bidding.
