<u>ORDER</u>

WHEREAS, the request is received from the Public Work Department, Daman that the work of the CC Road from Kachigam Char Rasta to Somnath Junction is under progress. There is a need to restrict traffic on the said route for smooth implementation of Civil Works;

WHEREAS, after satisfaction from the P.W.D., Daman request and after consultation with all stakeholders to avoid obstructions to the ongoing Civil works in the public interest. **I, RAHUL DEV BOORA, IAS, SUB DIVISIONAL MAGISTRATE, DAMAN** in exercise of the powers conferred on me under Sections 115 & 116 of the Motor Vehicle Act, 1988 hereby order to restrict traffic on following route and place for the period from 15/09/2024 to 13/10/2024 for 28 days in a manner as follows:

The Public is informed to take the alternate road from Kachigam Talav to Ringanwada. The Executive Engineer, P.W.D., Daman shall ensure to complete the aforementioned civil work on the above road within the prescribed time limit and make the road operational well in time.

Further, in the exercise of powers conferred under Section 116 of Motor Vehicle Act, 1988, I hereby direct the Superintendent of Police (Traffic), Daman and the Executive Engineer, P.W.D., Daman for Erection of Traffic Sign Board mentioned above for the purpose of regulating Motor Vehicle Traffic. Also Police Department is directed to deploy the necessary staff to avoid any Law & Order problem from road users.

In case of violation of the above, violating vehicles will be impounded and shall be released on payment of the prescribed penalty under the Motor Vehicle Act.

The Field Public Officer, Daman and the Superintendent of Police (Traffic), Daman are directed to give wide publicity of the order for informed compliance of Public.

This Order shall come into force from 15/09/2024 to 13/10/2024.
