The qualifying date for the preparation of the Electoral Roll is 01/01/2025.

If, with reference to the above said qualifying date, there be any claim for the inclusion of a name in the roll or any objection to the inclusion of name or any objection to particulars in any entry, it should be lodged on or before 28/11/2024 in Form 6, 6A, 7, 8 as may be appropriate.

An eligible citizens, who is going to attain the age of eighteen years on any of the subsequent qualifying dates in the year 2025, that is to say, the 1<sup>st</sup> April, 2025, the 1<sup>st</sup> July, 2025 or the 1<sup>st</sup> October, 2025, may also file his or her claim for inclusion of his or her name in the roll, in Form 6 in advance, starting from the date of notice, and the same shall be considered and decided in the respective quarter of the year with reference to the respective qualifying date.”

Every such claim or objection should either be presented in my office or to the AERO or to BLOs or sent by post to the address given below to reach me not later than the aforesaid date.

**ORDER**

The General Elections to the Legislative Assemblies of Maharashtra -2024 for Palghar Parliamentary Constituency of Maharashtra State are being held on 20/11/2024(Wednesday). In this regard, your attention is invited to section 135B of the Representation of People Act, 1951 which provides for the grant of paid holidays to the employees on the day of poll.

As per the provisions of section 135B of the Representation of People Act, 1951 all the electors who are employees of Government Offices, Semi- Government Offices, Local Bodies, Public Sector, Establishments and Shops including those which work on shift basis shall be granted a paid holiday on the day of poll in the Constituency where the General Election is to be held. Further, there may be case where a person is ordinarily resident of the Constituency and registered as an electors, may be serving/employed in an industrial undertaking or an establishment located outside the Constituency having a general/bye election. It is clarified that in such a situation, even those electors including casual workers working outside the constituency concerned would be entitled to the benefit of a paid holiday extended under the Section 1358(1) of R.P. Act, 1951. The daily wage/casual workers are also entitled for a holiday and wages on poll day as provided in Section 135B of R.P. Act, 1951.

All the employers of commercial establishments, business, trade, industrial undertaking or any other establishments are directed to abide by the provisions of section 135B of the Representation of People Act, 1951. If any employer contravenes with the provision mentioned above, then such employers shall be liable for punishment as per the provisions of Section 135B of Representation of the people Act, 1951.
