NOTIFICATION

[See Section 25 of the RFCTLARR Act, 2013]

AND WHEREAS, a Declaration No. 65-07-LAQ/2021-22/3222 dated 29/03/2022 was issued in accordance with the provisions as per sub-section (2) of section 19 of the Right to Fair Compensation and Transparency in Land Acquisition Act, 2013 for Additional Land Acquisition for Construction of New Govt. Guest House in place of existing Circuit House Annexe Building at Jalandhar Beach, Diu for an area admeasuring 1767.00 sq. mts.;

AND WHEREAS, as per section 25 of RFCTLARR Act, 2013, The Collector shall make an award within a period of twelve months from the date of publication of the declaration under section 19 and if no award is made within that period, the entire proceedings for the acquisition of the land shall lapse;

AND WHEREAS, as per section 25 of RFCTLARR Act, 2013, Government have the power to extend the period, if in its opinion circumstances exist justifying the same;

AND WHEREAS, it is requested to Government to extend the period to make Award by Collector (up to 24/07/2025) i.e. beyond twelve months from Declaration under Section 19 as "as informed by the standing counsel there is no ad-interim or interim relief granted by the Hon'ble High court which would prevent the authority to proceed ahead in the acquisition proceedings as per law.

Also it looks like the Writ Petition which is filed in High Court by affected party has been abandoned due to non pursuance of matter by affected party for long time. This inordinate long delay has defeated the time bound completion of land acquisition proceeding of public purpose project”;

NOW THEREFORE, sanction is accorded to extend the time limit for a further period till 24/07/2025 in publishing an Award by Collector by invoking the provisions contained in section 25 of RFCTLARR Act, 2013 with regard to the acquisition of 1767.00 sq. mts. of land in Diu District for Additional Land Acquisition for Construction of New Govt. Guest House in place of exiting Circuit House Annexe Building at Jalandhar Beach, Diu.
