NOTICE

WHEREAS, vide Preliminary Notification No. 3/119/LND-ACQ/2023-24/200 dated 12.01.2024, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of Acquisition of land for Construction of Government College of Nursing (GCON), Nursing Hostel and Staff Quarters, Daman.

WHEREAS, a report U/s. 15 of the Act, 2013 was submitted to the Government Authority i.e. Administrator of Dadra & Nagar Haveli and Daman & Diu addressing each and every objection of the objector and the same has been approved by the Appropriate Government i.e. Administrator of Dadra & Nagar Haveli and Daman & Diu.

WHEREAS, vide Declaration No. 3/119/LND-ACQ/2023-24/2143 dated 29.11.2024, it was declared under the provision of Section-19 of the Land Acquisition, Rehabilitation Act, 2013 that the said lands are required for the public purpose, i.e. Construction of Government College of Nursing (GCON), Nursing Hostel and Staff Quarters, Daman.

WHEREAS, in connection with the acquisition of land admeasuring 17008.00 sq. mtrs. for Construction of Government College of Nursing (GCON), Nursing Hostel and Staff Quarters, Daman, the Administration of Daman intends to take possession of the land, the particulars of which are given in the declaration u/s 19(1) of the Right to Fair Compensation & Transparency in Land Acquisition Rehabilitation and Resettlement (RFCTLARR) Act, 2013.

WHEREAS, under Section 21 of the RFCTLARR Act, 2013, the Government intend to take possession of the land, and claims to compensations and rehabilitation and resettlement for all interests in the land, has to be submitted to the Collector for disposal on or before 06/1/2025 at 18.00 hrs.

The details of compensation on the land acquisition as per Annexures-I, II & III are enclosed herewith.

WHEREAS, under sub section (1) & (2) of Section 22 of the said Act, the Collector may also require any such person to make or deliver to him a statement containing the name of every other person possessing any interest in the land or any part thereof as co-proprietor, sub-proprietor, mortgage, tenant or otherwise, and of the nature of such interest, and of the rents and profits, if any received or receivable on account thereof for three years next preceding the date of statement, every person required to make

or deliver a statement under this section shall be deemed to be legally bound to do so within the meaning of section 210 and 211 of the Bharatiya Nyaya Sanhita 2023 (No.45 of 2023)

Whereas, it appears to the appropriate Government that a total of **3140.66 Sq. Mtrs.** (standard measurement) land is required in Naroli (Executive Engineer, PWD, Civil Division No-I (Road)) of Dadra and Nagar Haveli for public purpose, namely, for Development of Entrance Gate and surrounding area in Naroli, the details of the land/lands for the above said project in the Naroli area of Dadra and Nagar Haveli District is mentioned below. The Social Impact Assessment (SIA) was carried out by the NH Consulting Pvt Ltd, New Delhi an Agency appointed by the Hon'ble Collector, Dadra and Nagar Haveli, Silvassa vide Notification No. LAQ/Entrance Gate/Naroli/2023/22/LAO/2024 dated: 16/01/2024 and a report submitted by the NH Consulting Pvt Ltd, New Delhi after preliminary investigation was conducted by a team constituted by Collector as laid down under rule 4. The summary of the Social Impact Assessment Report/ preliminary investigation is as follows (copy attached):

The total 3140.68 square meter of land being bought for the proposed project is spread out between Silvassa village, Dadra and Nagar Haveli, along the Construction of Development of Entrance Gate & Surrounding area at Naroli. The majority of the land's owners are private and governmental organizations. Under the terms of the RFCTLARR Act 2013, the Public Woks Department of Silvassa submitted a request for the acquisition of land to the UT Administration of Dadra and Nagar Haveli.

The proposed acquisition of the aforementioned land will have a significant impact on the income and livelihoods of those who rely on it, such as landowners, owner shopkeepers, and tenant households. The project social consequences are both immediate and indirect, affecting people and communities throughout its entire cycle. Construction activities=, for example, are likely to have a variety that may be adverse to the living and health conditions of affected populations during the development phase. Increased dust levels, air pollution from building and excavation, material preparation, and material stacking are all possibilities. Increasing machining activity will be a safety hazard for communities near the affected area.

Despite the fact that it is challenging to calculate the exact cost of social impact given the seriousness of land acquisition, efforts should be taken to offset unfavourable effects through intervention. Both tourist and residents of the nearby areas will gain a lot from this effort.

The planned project's impact on various types of structures, as well as the acquisition of private land, may entail social disturbance and economic loss for project-affected families/people. While implementing the project, it is necessary to consider the project's disruptions and losses, as well as their impact on people's socioeconomic conditions. If there are any alternatives to the proposed land

acquisition, they should be investigated. A plan of action for implementing mitigation measures to lessen the severity of negative impacts can be developed. According to the results of the socioeconomic survey, project affected families are willing to give up their land for the project only if they are adequately compensated under the RFCTLARR Act 2013 or the RFCTLARR (Rehabilitation and Resettlement, Development Plan) Rules 2015 of the Administration of Dadra and Nagar Haveli.

The Resident Deputy Collector, Silvassa is appointed as Administrator for the purpose of Rehabilitation and Resettlement of the affected families vide Notification no. LAQ/RFCTLARRA, 2013-2015/174 dated 11/08/2015 u/s 44 (1) and Section 43(1) of the Act-2013. Therefore, it is notified that for the above-said project in Dadra & Nagar Haveli District, a piece of land Admeasuring **3140.66 sq. mtr.** of standard measurement, whose detail description is as following, is under acquisition:

- 2. The Committee shall ensure time bound disposal of complaints and should involve a third party, either NGO or other body who is familiar with the issue of sexual harassment, while inquiring any complaint of sexual harassment.
- 3. The Committee shall make an annual report to the Administrator relating the Complaints received in the matter and action taken thereby.
- 4. Any woman employee may file a complaint with regard to the "Sexual Harassment" at the place of her posting with any of the member of the Committee, and the Committee shall take immediate action with regard to verification of such complaint and report their findings and recommendations to the Administrator within 30 days of receipt of the Complaint.
- 5. All Government Employees shall provide necessary assistance to the Committee in discharge of its functions. Failure to do so shall make them liable for disciplinary action.
- 6. The Sexual harassment as defined under rule 3-C of CCS (Conduct) Rules, 1964 has been amended by Government of India vide Notification dated 19/11/2014. The Amended Rule is as follows:
 - "Rule 3 (C) Prohibition of sexual harassment of working women
- (1) No Government Servant shall indulge in any act of sexual harassment of any women at her work place.
- (2) Every Government servant who is in-charge of a work place shall take appropriate steps to prevent sexual harassment to any woman at such work place.

Explanation -1 For the purpose of this rule,

- (a) "Sexual Harassment" includes any one or more of the following acts or behaviour, (whether directly or by implication) namely:
 - i) Physical contact and advances; or
 - ii) Demand or request for sexual favours; or
 - iii) Sexually coloured remarks; or
 - iv) Showing any pornography; or
 - v) Any other unwelcome physical, verbal or non-verbal conduct of a sexual nature.
- (b) The following circumstances, among other circumstances, if it occurs or is present in relation to or connected with any act or behaviour of sexual harassment may amount to sexual harassment:-
 - (i) implied or explicit promise of preferential treatment in employment; or
 - (ii) Implied or explicit threat of detrimental treatment in employment; or

- (iii) Implied or explicit threat about her present or future employment status; or
- (iv) Interference with her work or creating an intimidating or offensive or hostile work environment for her; or
- (v) Humiliating treatment likely to affect her health or safety
- (c) "workplace" includes -
 - (i) any department, organization, undertaking, establishment, enterprise, institution, office, branch or unit which is establishment, enterprise, institution, office, branch or unit which is established, owned, controlled or wholly or substantially financed by funds provided directly or indirectly by the Central Government;
 - (ii) hospitals or nursing homes;
 - (iii) any sports institute, stadium, sport complex or competition or games venue, whether residential or not used for training, sports or other activities relating thereto;
 - (iv) any place visited by the employee arising out of or during the course of employment including transportation provided by the employer for undertaking such journey;
 - (v) a dwelling place or a house.
- 7. The Chairperson and Members of the Committee are advised that the following procedure may be adopted while dealing with complaints of sexual harassment:-
 - (i) Sexual harassment will include any one or more of the Acts or behaviour defined in Rule 3-C of the CCS (Conduct) Rules 1964 read with Sec 3(2) of SHWW (PPR) Act.
 - (ii) The Committee constituted in each Ministry/Department/office under the CCS (Conduct) Rules, 1964 shall inquire into complaints of sexual harassment in accordance with the provisions of Section 4 of the SHWW (PPR) Act.
 - (iii) The Committee will as far as practicable follow the procedures prescribed in CCS (CCA) Rules 1965 for conduct of the inquiry.
 - (iv) If any complaint is received directly by the committee, the same shall be referred to the appropriate disciplinary authority and the Committee shall inquire into the complaint on the complaint being referred to it by the disciplinary authority.
- 8. In addition, the Committee will have the powers to recommend to the employer:
 - a) to transfer the aggrieved woman or the charged officer to any other workplace; or
 - b) to grant leave to the aggrieved woman up to a period of three months.

(The leave granted to the aggrieved woman under this section shall be in addition to the leave she would be otherwise entitled to.)

- c) to grant such other relief to the aggrieved woman as may be prescribed; or
- d) to deduct from the salary or wages of the charged officer such sum as it may consider appropriate to be paid to the aggrieved woman or to her legal heirs. Any amount outstanding at the time of cessation of the services of the charged officer due to retirement, death of otherwise may be recovered from the terminal benefits payable to the officer or his heirs. Such compensation will not amount to penalty under Rule 11 of CCS (CCA) Rules in terms of the Explanation (ix) to Rule 11 inserted vide Notification of even Number dated 19/11/2014.
- 9. It may also be noted that the Committee may recommend action to be taken against the person who has made a complaint, if the Committee arrives at the conclusion that the allegation is malicious or the aggrieved woman or the person making the complaint has made the complaint knowing it to be false or has produced any forged or misleading document. The Committee may also recommend action against any witness if it comes to the conclusion that such witness has given false evidence or produced any forged or misleading document.
- 10. Attention is also invited to the following provisions of Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act:
 - Sec 16 & 17: Prohibition of publication or making known content of complaint, inquiry proceedings and recommendations of the Committee.
 - Sec 19: Duties of employer. Thus may be read with provisions of Rule 3 (C) (2) of CCS (Conduct) Rules.
 - Sec 21, 22 of SHWW (PPR) Act and Rule 14 of the SHWW (PPR) Rules, Annual Reports.

The Appropriate Government Administration of Daman and Diu, U.T., Daman was of the opinion that, an industrial dispute exists between the First party and Second party in respect of the matter of the demand of the second party is justified and what relief he is entitled to. Therefore in exercise of the power conferred by clause 'c' of Sub Section 1 of section 10 of the Industrial Dispute Act- 1947, the Appropriate Government has referred this industrial dispute for adjudication to this Labour Court of Daman, vide letter bearing No.LE/LI/DMN/FACT-65/2019/757, dated 27/12/2019, which is received by this Court on 03/01/2020.

- 2) Accordingly notices were issued to both the parties as per procedure prescribed under Section 11 of the Industrial Dispute Act 1947. In response to the notice both parties appeared before this Court. However, second party failed to file his statement of claim.
- 3) On consideration of conciliation failure report, it appears that second party had been worked with first party company as Manager-HR & Admn. and resigned on 4th February, 2019. He claimed that he has still not received compensation. The first party appeared and resisted the claim before conciliation. They denied the allegations, claims, contains and averments made in the complaint in toto, as the same is baseless, fictitious and made motive to extract undue monetary gain from the management without any justification. They stated that they have paid full and final settlement to the second party amounting Rs. 1,41,163/- vide cheque No. 479256 dated 23/04/2019.
- 4) However, the second party has not filed the statement of claim, even he has not adduced any evidence. Thus, he has failed to substantiate his claim and therefore, I answer the reference in the negative and accordingly disposed off.

ORDER

- 1) The reference is answered in the negative.
- 2) An award be submitted to the appropriate Government for it's publication as per section 17 of the Industrial Dispute Act, 1947.

The ICGAS has decided to acquire land for the expansion of runway 3/21, enabling the operation of larger defense and passenger aircraft.

Details of the proposed facilities and benefits are as follows:

• Proposed National Security Facilities:

Expansion aims to support larger military aircraft for troop deployment, maritime border patrol, surveillance, and rescue operations in the Arabian Sea.

Enhancements will improve air safety for various scenarios like aborted take-offs, single-engine landings, high-temperature take-offs, and night operations.

• Transport-Related Facilities:

Large civil aircraft under the RCS/UDAN scheme will operate, improving air connectivity for Daman and surrounding areas, making air travel more affordable. The expansion will also facilitate the installation of an Instrument Landing System (ILS) for safer landings.

- A. Deployment of troops/artillery, patrolling the maritime border in the Arabian Sea by large aircraft, surveillance, rescue of Ships/men in distress. Protecting maritime borders. To facilitate the operation of large military aircraft with full load operations to meet emerging challenges such as aerial search and rescue operations and high-altitude descents for paratroopers etc.
- B. Air safety will be enhanced under the following circumstances.
 - i. Abort take-off/single-engine landing,
 - ii. Take off at a high temperature.

iii. Night operation and landing

The numbers of families that may/are likely to be displaced due to the land acquisition will be known only after the survey for R&R initiated U/s.16 of the Act 2013.
