प्रशासक, दादरा एवं नगर हवेली तथा दमण एवं दीव संविधान के अनुच्छेद 309 के परन्तुक के अंतर्गत भारत सरकार, गृह मंत्रालय, नई दिल्ली की अधिसूचना सं. 7/1/65-स्था(ए), दिनांक 16 फरवरी, 1965 तथा कार्मिक एवं प्रशिक्षण विभाग, नई दिल्ली के कार्यालय ज्ञापन सं. ए.बी.-14017/13/2016-स्था(भ.नि.), दिनांक 18 जनवरी, 2017 के तहत प्रदत्त शक्तियों का प्रयोग करते हुए संघ प्रदेश दादरा एवं नगर हवेली तथा दमण एवं दीव प्रशासन के तकनीकी शिक्षा संस्थानों (डिप्लोमा) में प्राचार्य, सामान्य केन्द्रीय सेवा, समूह-'क' (राजपत्रित एवं अलिपिकीय) पद पर भर्ती की पद्धति को विनियमित करने के लिए निम्नलिखित नियम बनाते हैं :-

<u>संक्षिप्त नाम, अनुप्रयोग एवं प्रारंभ :-</u>

(i) इन नियमों को ''संघ प्रदेश दादरा एवं नगर हवेली तथा दमण एवं दीव प्रशासन, प्राचार्य,
 सामान्य केन्द्रीय सेवा, समूह-'क' (राजपत्रित, अलिपिकीय) पद के लिए भर्ती नियम,
 2024'' कहा जाएगा ।

(ii) ये इस नियम की अनुसूची के कॉलम – 1 में विनिर्दिष्ट पदों के लिए लागू होंगे ।

(iii) ये नियम सरकारी राजपत्र में इस अधिसूचना के प्रकाशन की तारीख से प्रभावी होंगे और इस तिथि को या उसके बाद विभिन्न पदों पर नियुक्ति के लिए प्रयुक्त होंगे ।

2. पदों की संख्या, वर्गीकरण एवं वेतनमान :-

इससे संबद्ध पदों की संख्या, उनका वर्गीकरण और वेतनमान वही होंगे, जो इस नियम के साथ संलग्न अनुसूची के कॉलम-2 से 4 में विनिर्दिष्ट हैं : बशर्ते कि संघ प्रदेश दादरा एवं नगर हवेली तथा दमण एवं दीव प्रशासन कार्य की आकस्मिकताओं के मद्देनज़र समय-समय पर उक्त अनुसूची के कॉलम - 2 में पदों की संख्या में परिवर्तन कर सकता है ।

3. भर्ती पद्धति, आयु सीमा एवं अन्य अर्हताएं :-

उक्त पदों पर भर्ती की पद्धति, आयु सीमा, अर्हताएं और उनसे संबंधित अन्य बातें वही होंगी, जो उक्त अनुसूची के कॉलम-5 से 13 में विनिर्दिष्ट हैं ।

4. <u>अनर्हता :-</u>

ऐसा कोई व्यक्ति, (क) जिसने किसी ऐसे व्यक्ति से विवाह किया हो या विवाह का अनुबंध किया हो, जिसकी पत्नी/जिसका पति जीवित हो, या (ख) जिसने अपनी पत्नी/अपने पति के जीवित रहते हुए किसी अन्य व्यक्ति से विवाह किया हो या विवाह का अनुबंध किया हो, वह उक्त पद पर नियुक्ति का पात्र नहीं होगा । परन्तु यदि प्रशासक, दादरा एवं नगर हवेली तथा दमण एवं दीव इससे संतुष्ट हो जाएं कि ऐसा विवाह उस व्यक्ति और विवाह के अन्य पक्षकार को लागू स्वीय विधि (पर्सनल लॉ) के तहत स्वीकार्य है और यह कि ऐसा करने के लिए अन्य आधार हैं, तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकते हैं ।

5. <u>शिथिल करने की शक्ति :-</u>

जहां प्रशासक, दादरा एवं नगर हवेली तथा दमण एवं दीव की यह राय हो कि ऐसा करना आवश्यक या समीचीन है, तो वहां वे आदेश द्वारा और उसके लिए जो कारण हैं, उन्हें लेखबद्ध करके इन नियमों के किसी भी उपबंध को किसी वर्ग या श्रेणी के व्यक्तियों के संबंध में शिथिल कर सकेंगे ।

6. <u>व्यावृत्ति :-</u>

इन नियमों की कोई बात, ऐसे आरक्षण, आयु सीमा में छूट और अन्य रियायतों पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर जारी किए गए आदेशों के अनुसार अनुसूचित जातियों तथा अनुसूचित जनजातियों एवं अन्य विशेष प्रवर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है ।

NOTIFICATION

In exercise of the powers conferred under proviso to Article 309 of the Constitution delegated to him vide Government of India, Ministry of Home Affairs, New Delhi's Notification No.7/1/65-Est(A) dated 16th February, 1965 and Department of Personnel and Training, New Delhi O.M. No. AB-14017/13/2016-Estt. (RR) dated 18th January, 2017, the Administrator of Dadra & Nagar Haveli and Daman & Diu is pleased to make the following Rules regulating the method of recruitment to the General Central Service, Group "A" (Gazetted & Non-Ministerial) post of <u>Principals</u> in Technical Educational Institutions (Diploma) under the U.T. Administration of Dadra & Nagar Haveli and Dadra & Nagar Haveli and Daman & Diu are as under: -

1. <u>SHORT TITLE APPLICATION AND COMMENCEMENT: -</u>

- (i) These rules may be called by the "U.T Administration of Dadra & Nagar Haveli and Daman & Diu, General Central Services Group "A" (Gazetted, Non-Ministerial) post of **Principals** in Technical Education Institutions (Diploma) services Recruitment Rules, 2024."
- (ii) They shall apply to the posts specified in column 1 of the Schedule to these Rules.
- (ii) These rules will come into effect from the date of publication of this Notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.
- 2. <u>NUMBER OF POSTS, CLASSIFICATION AND SCALE OF PAY: -</u> The number of posts, classification of the said posts and the scales of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule to these rules: Provided that, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu may vary the number of posts in Column No.2 of the said schedule from time to time subject to exigencies of the work.

3. <u>METHOD OF RECRUITMENT, AGE LIMIT AND OTHER</u> <u>QUALIFICATION: -</u>

The method of recruitment to the said posts, age limits, qualifications and other matters connected therewith shall be as specified in Column 5 to 13 of the aforesaid Schedule.

- 4. <u>DISQUALIFICATION:-</u> No Person (a) Who has entered into or contracted a marriage with a person having a spouse living, or (b) Who, having spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service Provided that, the Administrator of Dadra & Nagar Haveli and Daman & Diu may, if satisfied that such marriage is permissible under the personnel law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person form the operation of this rule.
- 5. <u>POWER TO RELAX: -</u> Where the Administrator of Dadra & Nagar Haveli and Daman & Diu is of the opinion, that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provision of these rules with respect to any class or category of persons.
- 6. <u>SAVING: -</u>Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes and Scheduled Tribes and other Special Categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
- This is issued with the approval of the Union Public Service Commission (UPSC), New Delhi vide Note No. 10760 dated 12/09/2024.

<u>NOTICE</u>

WHEREAS, vide Preliminary Notification No. 3/117/LND-ACQ/2022-23/398 dated 15.03.2024, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of Acquisition of land for Girls Hostel and Staff Quarters in respect of National Institute of Fashion Technology, Daman.

WHEREAS, a report U/s. 15 of the Act, 2013 was submitted to the appropriate Government i.e. Administrator of Dadra & Nagar Haveli and Daman & Diu addressing each and every objections of the objectors and the same has been approved by the appropriate Government i.e. Administrator of Dadra & Nagar Haveli and Daman & Diu.

WHEREAS, vide Declaration No. 3/117/LND-ACQ/2022-23/120 dated 24.01.2025, it was declared under the provision of Section-19 of the Land Acquisition, Rehabilitation Act, 2013 that the said lands are required for the public purpose, i.e. Girls Hostel and Staff Quarters in respect of National Institute of Fashion Technology, Daman.

WHEREAS, in connection with the acquisition of land admeasuring **10521.00 sq. mtrs.** for Girls Hostel and Staff Quarters in respect of National Institute of Fashion Technology, Daman, the Administration of Daman intends to take possession of the land, the particulars of which are given in the declaration u/s 19(1) of the Right to Fair Compensation & Transparency in Land Acquisition Rehabilitation and Resettlement (RFCTLARR) Act, 2013.

WHEREAS, under Section 21 of the RFCTLARR Act, 2013, the Government intends to take possession of the land, and the claims to compensations and rehabilitation and resettlement for all interests in the land, has to be submitted to the Collector for disposal on or before 03/03/2025 till 18.00 hrs.

The details of compensation on the land acquisition as per Annexures– I, II & III are enclosed herewith.

WHEREAS, under sub section (1) & (2) of Section 22 of the said Act, the undersigned may also require any such person to make or deliver to him a statement containing the name of every other person possessing any interest in the land or any part thereof as co-proprietor, sub-proprietor, mortgage,

tenant or otherwise, and of the nature of such interest, and of the rents and profits, if any received or receivable on account thereof for three years next preceding the date of statement, every person required to make or deliver a statement under this section shall be deemed to be legally bound to do so within the meaning of section 210 and 211 of the Bharatiya Nyaya Sanhita 2023 (No.45 of 2023)

जबकि, भारतीय प्रेस परिषद (Press Council of India - PCI), नई दिल्ली द्वारा प्राप्त पत्र के द्वारा यह संज्ञान में लाया गया है कि भारतीय प्रेस परिषद का सचिवालय, सूचना भवन, सीजीओ कॉम्प्लेक्स, लोढ़ी रोड, नई दिल्ली में स्थित है तथा उक्त परिषद ने न तो किसी शाखा (Branch) की स्थापना की है और न ही किसी अन्य निकाय को अपने नाम या समान नाम से कार्य करने के लिए अधिकृत किया है।

और जबकि, भारतीय प्रेस परिषद (PCI), नई दिल्ली के संज्ञान में यह आया है कि कुछ प्रेस संगठनों द्वारा "प्रेस परिषद" (Press Council) शब्द का उपयोग किया जा रहा है, जिससे न केवल भारतीय प्रेस परिषद की संस्थागत प्रतिष्ठा को क्षति पहुँची है, बल्कि इसके विशिष्ट अधिकार क्षेत्र और नाम का भी उल्लंघन हुआ है।

और जबकि, विधि विभाग, नई दिल्ली ने यह राय दी है कि केन्द्र सरकार की अनुमति के बिना किसी अन्य संगठन द्वारा "Press Council" या इसके हिंदी समकक्ष "भारतीय प्रेस परिषद" शब्द के उपयोग करना, "प्रतीक और नाम (अनुचित उपयोग की रोकथाम) अधिनियम, 1950" की धारा 3 एवं प्रविष्टि 7(ii) का उल्लंघन है।

अब इसीलिए, यह परामर्श (अड़वाइज़री) जारी किया जाता है कि:

WHEREAS, it has brought to the notice through a letter received from the Press Council of India (PCI), New Delhi that its Secretariat is located at Soochna Bhawan, CGO Complex, Lodhi Road, New Delhi, and it has neither established any branch nor authorised/constituted any other body with the same or similar name to function on its behalf;

AND WHEREAS, it has come to the knowledge of the Press Council of India (PCI), New Delhi that certain press organisations are using the term "Press Council", which has not only eroded the institutional value of the Press Council of India but also infringes upon its unique domain and title.

AND WHEREAS, the Department of Legal Affairs, New Delhi, has opined that the usage of the term "Press Council" or its Hindi equivalent "भारतीय प्रेस परिषद" by any other organisation without the permission of the Central Government is in violation of Section 3 read with Entry 7(ii) of the Emblems and Names (Prevention of Improper Use) Act, 1950.

NOW THEREFORE, it is hereby advised that:

- All concerned authorities must take necessary steps to prohibit and rectify the registration of any local or government association/body using the name "Press Council" or "भारतीय प्रेस परिषद".
- 2. Organizations or individuals currently using this term without authorisation must cease such usage immediately to avoid legal consequences.

 Strict action will be taken against any entity found misusing the name of the Press Council of India in violation of the law.

This advisory is issued with the approval of the Competent Authority in the interest of maintaining the integrity and legal sanctity of the Press Council of India, New Delhi.
