#### 1. <u>संक्षिप्त नाम, अनुप्रयोग एवं प्रारंभ :-</u>

- (i) इन नियमों को ''संघ प्रदेश दादरा एवं नगर हवेली तथा दमण एवं दीव प्रशासन द्वारा व्याख्याता, सामान्य केन्द्रीय सेवा, समूह-'क' (राजपत्रित एवं अलिपिकीय) पद के लिए भर्ती नियम, 2024'' कहा जाएगा।
- (ii) ये नियम इन नियमों की अनुसूची के कॉलम 1 में निर्दिष्ट पदों पर लागू होंगे।
- (iii) ये नियम सरकारी राजपत्र में इस अधिसूचना के प्रकाशन की तारीख से प्रभावी होंगे और इस तिथि को या उसके बाद विभिन्न पदों पर नियुक्ति के लिए प्रयुक्त होंगे ।

#### 2. पदों की संख्या. वर्गीकरण एवं वेतनमान :-

इससे संबद्घ पदों की संख्या, उनका वर्गीकरण और वेतनमान वही होंगे, जो इस नियम के साथ संलग्न अनुसूची के कॉलम-2 से 4 में विनिर्दिष्ट हैं : बशर्ते कि संघ प्रदेश दादरा एवं नगर हवेली तथा दमण एवं दीव प्रशासन कार्य की आकस्मिकताओं के मद्देनज़र समय-समय पर उक्त अनुसूची के कॉलम - 2 में पदों की संख्या में परिवर्तन कर सकता है।

#### 3. भर्ती पद्धति, आयु सीमा एवं अन्य अर्हताएं :-

उक्त पदों पर भर्ती की पद्धति, आयु सीमा, अर्हताएं और उनसे संबंधित अन्य बातें वही होंगी, जो उक्त अनुसूची के कॉलम-5 से 13 में विनिर्दिष्ट हैं ।

#### 4. <u>अनर्हता :-</u>

ऐसा कोई व्यक्ति, (क) जिसने किसी ऐसे व्यक्ति से विवाह किया हो या विवाह का अनुबंध किया हो, जिसकी पत्नी/जिसका पित जीवित हो, या (ख) जिसने अपनी पत्नी/अपने पित के जीवित रहते हुए किसी अन्य व्यक्ति से विवाह किया हो या विवाह का अनुबंध किया हो, वह उक्त पद पर नियुक्ति का पात्र नहीं होगा । परन्तु यदि प्रशासक, दादरा एवं नगर हवेली तथा दमण एवं दीव इससे संतुष्ट हो जाएं कि ऐसा विवाह उस व्यक्ति और विवाह के अन्य पक्षकार को लागू स्वीय विधि (पर्सनल लॉ) के तहत स्वीकार्य है और यह कि ऐसा करने के लिए अन्य आधार हैं, तो वह किसी व्यक्ति को इस नियम के प्रवर्तन से छूट दे सकते हैं ।

#### 5. शिथिल करने की शक्ति :-

जहां प्रशासक, दादरा एवं नगर हवेली तथा दमण एवं दीव की यह राय हो कि ऐसा करना आवश्यक या समीचीन है, तो वहां वे आदेश द्वारा और उसके लिए जो कारण हैं, उन्हें लेखबद्ध करके इन नियमों के किसी भी उपबंध को किसी वर्ग या श्रेणी के व्यक्तियों के संबंध में शिथिल कर सकेंगे।

#### 6. <u>व्यावृत्ति :-</u>

इन नियमों की कोई बात, ऐसे आरक्षण, आयु सीमा में छूट और अन्य रियायतों पर प्रभाव नहीं डालेगी, जिनका केन्द्रीय सरकार द्वारा इस संबंध में समय-समय पर जारी किए गए आदेशों के अनुसार अनुसूचित जातियों तथा अनुसूचित जनजातियों एवं अन्य विशेष वर्ग के व्यक्तियों के लिए उपबंध करना अपेक्षित है।

#### **SHORT TITLE APPLICATION AND COMMENCEMENT: -**

- (i) These rules may be called by the Administration of Dadra & Nagar Haveli and Daman & Diu, for **Lecturers** General Central Services Group 'A' (Gazetted, Non-Ministerial) posts Recruitment Rules, 2024.
- (ii) They shall apply to the posts specified in column 1 of the Schedule to these Rules.
- (ii) These rules will come into effect from the date of publication of this Notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.
- 1. NUMBER OF POSTS, CLASSIFICATION AND SCALE OF PAY: The number of posts, classification of the said posts and the scales of pay attached thereto shall be as specified in Column 2 to 4 of the Schedule to these rules: Provided that, the U.T. Administration of Dadra & Nagar Haveli and Daman & Diu may vary the number of posts in Column No.2 of the said schedule from time to time subject to exigencies of the work.

#### 3. METHOD OF RECRUITMENT, AGE LIMIT AND OTHER QUALIFICATION: -

The method of recruitment to the said posts, age limits, qualifications and other matters connected therewith shall be as specified in Column 5 to 13 of the aforesaid Schedule.

- 4. <u>DISQUALIFICATION:-</u> No Person (a) Who has entered into or contracted a marriage with a person having a spouse living, or (b) Who, having spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the service Provided that, the Administrator of Dadra & Nagar Haveli and Daman & Diu may, if satisfied that such marriage is permissible under the personnel law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person form the operation of this rule.
- 5. <u>POWER TO RELAX: -</u> Where the Administrator of Dadra & Nagar Haveli and Daman & Diu is of the opinion, that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing relax any of the provision of these rules with respect to any class or category of persons.
- **SAVING:** Nothing in these rules shall affect reservation, relaxation of age limit and other concessions required to be provided for Scheduled Castes and Scheduled Tribes and other Special Categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Whereas, it appears to the appropriate Government that a total of **5301 Sq. Mtrs.** (**Private land**) (standard measurement) land is required in Khanvel Village of Dadra and Nagar Haveli for public purpose, namely, for the **Development of School Campus in Khanvel Village, D&NH**. The Social Impact Assessment study was carried out by Social Impact Assessment (SIA) Unit and a report submitted/preliminary investigation was conducted by a team constituted by Collector as laid down under rule 4. The Summary of the Social Impact Assessment Report/preliminary investigation is as follows (Copy attached):

- i. The proposed land acquisition is the bare minimum needed for the project, and there are no other options for the project. These parcels of land are owned by a number of private parties and the RFCTLARR Act requires compensation in the form of the value of unoccupied land and other assets.
- ii. One of the main purposes of the Social Impact Assessment Report is to find out if the project will help the public. Based on this estimate, the Construction/Development of School Campus Should support development of education facility and increase in sports activity.
- iii. The project will encourage Construction/Development of School Campus under the SIA project will serve as a cornerstone for fostering quality education and holistic development. With its modern infrastructure, eco-friendly design, and student-centric facilities, the campus will create an ideal environment for learning, innovation, and growth. This initiative reflects a commitment to empowering future generations and building a brighter, more educated community. Due to the establishment of employment opportunities both during and after the project's implementation, Benefits could be realized which are both tangible and intangible. Also, it will also have socioeconomic advantages.
- iv. The planned project's impact on various types of structures, as well as the acquisition of private land, may entail social disturbance and economic loss for project-affected families/people. While implementing the project, it is necessary to consider the project's disruptions and losses, as well as their impact on people's socioeconomic conditions. If there are any alternatives to the proposed land acquisition, they should be investigated. A plan of action for implementing mitigation measures to lessen the severity of negative

impacts can be developed. According to the results of the socioeconomic survey, project affected families are willing to give up their land for the project only if they are adequately compensated under the RFCTLARR Act 2013 or the RFCTLARR (Rehabilitation and Resettlement, Development Plan) Rules 2014 of the Administration of Dadra and Nagar Haveli.

#### Preface:-

Vide Notification No. 3/124/LND-ACQ/2024-25/3448 dated 08.08.2024 proposal for land acquisition area admeasuring private land is 22209.00 Sq.mtrs. and 1876.00 Sq.mtrs. of Government land total area admeasuring 24085.00 Sq.mtrs of Dunetha, Nani Daman was notified u/s 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 for a public purpose, namely, Acquisition of land for Development of Government Campus, Nani Daman. The Collector, Daman is the Land Acquisition Collector under the RFCTLARR Act 2013.

Vide Notification No.5/2/COL/Land/RFCTLARR/2015-16/2296 dated 04/08/2015, the Deputy Collector (HQ), Daman was appointed as the Administrator under sub section (1) of Section 43 of the said act for Rehabilitation and Resettlement of affected families due to acquisition of the said land as mentioned above.

#### **Introduction:-**

Upon receiving the proposal of Land Acquisition from the Requiring Department, i.e. the Director, Higher and Technical Education, DNH & DD a meeting was conducted by the SIA Committee on 24.04.2024. The affected parties and families were explained in detail the reasons for the land acquisition, and the process that shall be followed in the calculation of the compensation as per the provisions of the RFCTLARR Act 2013. During the Public meeting, particulars of lands and immovable properties being acquired of each affected family, Livelihoods primarily dependent on the lands being acquired, Public utilities likely to be affected, Common property resources, etc were discussed. A meeting of the Expert Group u/s 7 of the Act was held on 02/07/2024.

#### Methodology:-

As per section 16 of the RFCTLARR Act 2013, the Preparation of Rehabilitation and Resettlement Scheme should be done by the Administrator. Therefore, the undersigned directed to the Mamlatdar, Daman to visit each affected families and gather the details of their properties, livelihood and other relevant information as required by the Act. Accordingly, the staff of the Mamlatdar, Daman visited 42 Private lands and 10 Government lands and collected the details as required.

#### Rehabilitation & Resettlement Plan:-

Based on the survey Reports, a draft Rehabilitation and Resettlement scheme was prepared. This Rehabilitation and Resettlement scheme is drafted in consonance with provisions of the RFCTLARR (Compensation, Rehabilitation and Resettlement and Development Plan) Rules 2015.

#### Findings:-

As per the Section 3(k) of RFCTLARR Act 2013, "Displaced Family" means any family who on the account of acquisition of land has to be relocated and resettled from the affected area to the resettlement area. In the present case, it is evident that the affected family does not need relocation and resettlement since no family is being displaced from their residential house/commercial land. The land being acquired is for the purpose of Acquisition of land for Development of Government Campus, Nani Daman for which compensation shall be paid as and when the Land Acquisition Collector pass the Award. Hence, a Rehabilitation and Resettlement Scheme is not required.

- 1 Name of Project: Acquisition of land for the Development of the Government Campus, Nani Daman.
- 2 Name/ Names of person interested in the land and the nature of respective claim for rehabilitation and resettlement: As mentioned below.
- Time limit for provisions of Rehabilitation and Resettlement entitlements given to the affected family: Within 06 months from date of Award u/s 23 of RFCTLARR Act 2013
- 4 Rehabilitation and Resettlement entitlements
  - 1. Provision of housing units in case of displacement
  - (1) If a house is lost in rural areas, a constructed house shall be provided as per the Indira Awas Yojana specifications. If a house is lost in urban areas, a constructed house shall be provided, which will be not less than 50 sq. mts. in plinth area.
  - (2) The benefits listed above shall be extended to any affected family which is without homestead land and which has been residing in the area and which has been involuntarily displaced from such area:

Provided that any such family in urban areas which opts not to take the house offered, shall get a one-time assistance for house construction, which shall not be less than one lakh fifty thousand rupees:

Provided further that if any affected family in rural areas so prefers, the entitlement cost of the house may be offered in lieu of the constructed house:

Provided also that no family affected by acquisition shall be given more than one house under the provisions of this Act.

#### **Recommendation:**

Not Applicable as no housing units have been affected.

#### 2. Land for land

In case of Irrigation project, as far as possible and in lieu of compensation to be paid for land acquired, each affected family owning agriculture land in the affected area and whose land has been acquired or lost, or who has, as a consequence of the acquisition or loss of land, been reduced to the status of a marginal farmer or landless, shall be allotted, in the name of each person included in the records or rights with regard to the affected family, a minimum of one acre of land in the command area of the project for which the land is acquired:

Provided that in every project those person losing land and belonging to the Scheduled Castes or Scheduled Tribes will be provided land equivalent to land acquired or two and a half-acres, whichever is lower.

#### Recommendation-

Not Applicable as it is not an irrigation project.

#### 3. Offer for developed land

In case the land is acquired for urbanization purposes, twenty five percent of the developed land will be reserved and offered to land owing project affected families, in proportion to the area of their land acquired and at a price equal to the cost of acquisition and the cost of development.

Provided that in case the land owing project affected family wishes to avail this offer, an equivalent amount will be deducted from the land acquisition compensation package payable to it.

#### **Recommendation-**

Not Applicable as land is not being acquired for urbanization purpose.

#### 4. Choice of annuity or Employment

The appropriate government shall ensure that the affected families are provided with following option: -

- (a) Job may be given to at least one member per affected family in the project or arrange for a job in such other project as may be required and providing suitable training and skill development in the required field or make provision for employment at a rate not lower than the minimum wages provided for in any other law for the time being enforced. or
- (b) One time grant of ₹.5 lakh rupees per affected family. Or
- (c) The affected family will be provided with an annuity payment of Rupees 2000 per month per family for twenty years (this will be adjusted for inflation annually).

#### **Recommendation:**

Not Applicable as no annuity or Employment has been affected.

#### 5. Subsistence grant for displaced families for a period of one year

Each affected family which is displaced from the land acquired shall be given a monthly subsistence allowance equivalent to three thousand rupees per month for a period of one year from the date of award.

In addition to this amount, the Scheduled Castes and the Scheduled Tribes displaced from Scheduled Areas shall receive an amount to fifty thousand rupees.

In cases of displacement from the Scheduled Areas, as far as possible, the affected families shall be relocated in a similar ecological zone, so as to preserve the economic opportunities, language, culture and community life of the tribal communities.

#### **Recommendation:**

Not Applicable as there is no displacement.

#### 6. Transportation cost for displaced families

Each affected family which is displaced shall get one-time financial assistance of fifty thousand rupees as transportation cost for shifting of the family, building materials, belongings and cattle.

#### Recommendation-

Not Applicable as there is no displacement.

#### 7. Cattle shed/ petty shops cost

Each affected family having cattle or having a petty shop shall get one-time financial assistance of such amount as the appropriate Government may, by notification, specify subject to a minimum of twenty-five thousand rupees for construction of cattle shed or petty shop as the case may be.

**Recommendation-** Not Applicable as there is no Cattle shed/ petty shop

#### 8. One-time grant to artisan, small traders and certain others

Each affected family of an artisan, small trader or self-employed person or an affected family which owned non-agricultural land or commercial, industrial or institutional structure in the affected area due to land acquisition, shall get one-time financial assistance of such amount as the appropriate Government may, by notification specify subject to a minimum of twenty-five thousand rupees.

Recommendation- Not Applicable as there are no artisans, small traders, and certain others are affected.

#### 9. Fishing Rights

In cases of Irrigation or hydel projects, the affected families may be allowed fishing rights in the reservoirs, in such manner as may be prescribed by the appropriate government.

#### **Recommendation-**

Not Applicable as it is not an irrigation or hydel project.

#### 10. One-time Resettlement Allowance

Each Affected family shall be given one time "Resettlement Allowance" of fifty thousand rupees only.

#### **Recommendation:**

Not Applicable as there is no displacement.

#### 11. Stamp duty and registration fee

- (1) The stamp duty and other fees payable for registration of the land or house allotted to the affected families shall be borne by the Requiring Body.
- (2) The land for house allotted for the affected families shall be free from all encumbrances.
- (3) The land or house allotted may be in the joint names of wife and husband of the affected families.
