Draft Report of the Administrator for Rehabilitation and Resettlement Scheme u/s 16 of the Right to Fair Compensation and Transparency in Land Acquisition from Kohinoor to Malala Junction Strengthening and Widening of NH-251 from Km 11.000 to Km 22.770 at District Diu

Preface:-

Vide Preliminary Notification No. 65-02-LAQ-2022-23/1191 dated 19/11/2024 (Copy attached as Annexure-A), land admeasuring total 9853.23 Sq.mtrs.in Diu District was notified u/s 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, project for namely "Land Acquisition from Kohinoor to Malala Junction Strengthening and Widening of NH-251 from Km 11.000 to Km 22.770 at District Diu", for public purpose as defined in Section 2(1) (vi) of the RFCTLARR Act, 2013.

Vide Notification No. 5/2/COL/Land/RFCTLARR/2015-16/2296 dated 04/08/2015, the undersigned has been appointed as the Administrator under sub section (1) of Section 43 of the said act for Rehabilitation and Resettlement of affected families due to acquisition of the said land parcels.

As per section 16 of RFCTLARR Act 2013, Preparation of Rehabilitation and Resettlement Scheme by the Administrator should be done.

Methodology:-

As per chapter VI, procedure and manner of Rehabilitation and Resettlement Section 43 of RFCTLARR Act, 2013, the undersigned has been appointed as the Administrator to prepare Rehabilitation and Resettlement scheme.

Therefore, vide order No. 65-02-LAQ-2022-23/1388 dated 26/12/2024, a committee was constituted to obtain a report on Section 16 of RFCTLARR Act 2013 and Rule 7 of RFCTLARR (Compensation, Rehabilitation and Resettlement and Development Plan) Rules 2015, to conduct a field survey of proposed land. On 28/02/2025, with concerned Talathi of the area, Planning Assistant, Diu, EOCS, Diu and Mamlatdar, Diu had visited the sites. The report dated 04/03/2025 have been received from Mamlatdar, Diu.

Rehabilitation and Resettlement Plan

As per chapter VI, procedure and manner of Rehabilitation and Resettlement Section 43 of

RFCTLARR Act, 2013, the Rehabilitation and Resettlement scheme (RR Scheme) is drafted in

consonance with section 16 and Second Schedule of the RFCTLARR Act, 2013 and Rule 7 of

RFCTLARR (Compensation, Rehabilitation and Resettlement and Development Plan) Rules, 2015.

Findings:-

As per the section 3(k) of RFCTLARR Act 2013, "Displaced Family" means any family who

on the account of acquisition of land has to be relocated and resettled from the affected area to the

resettlement area. In the present case, the land being acquired is not used by affected family for

residential purpose. It is evident that the affected family does not need relocation and resettlement as

per the report of joint field survey as mentioned earlier.

Therefore, Rehabilitation and Resettlement scheme is not applicable for proposed land

acquisition.

NOTIFICATION

In pursuance to the Notification No. ADM/LAW/Pond Deepening/DNH/191/2021/822 Dated 06/05/2022, issued by the Joint Secretary (Mines), UT of DNH & DD, the following Survey Number located in the Jurisdiction of Dadra & Nagar Haveli District is hereby notified for the purpose of carrying out the activities of desilting and deepening of ponds/ lakes and water bodies and for extraction of Murum, Kankar, Sand and Stone for the said purpose.

The rate of Royalty has been declared as "NIL" for the purpose of carrying out the work of desilting/digging and deepening of ponds/lakes and water bodies and the extraction of Murrum, Kankar, Sand and Stone for the purpose of being used in Government Works, Public Works shall be as per the provision of Rule 56 of the Dadra & Nagar Haveli Minor Mineral Rules, 2013.

The above provisions shall be subject to the following conditions:

- 1. Prior permission/consent for the deepening the pond / lake should be taken from the Collector, Dadra & Nagar Haveli District before the deepening and ensure, that no damage to be caused to clay wall/other structure works/ structure, of pond, as well as ensure that deepening be done so as to maximize and efficient use of storage of water.
- During the excavation, if other minerals except plain soil / slit / murrum are found, the Collector
 of Dadra & Nagar Haveli District concerned should be informed and not to move such minerals.
 Transport or storage of such minerals will be considered unauthorized.

- 3. Soil, Murrum received due to deepening of ponds/ reservoirs cannot be sold and to be used as per provision only.
- 4. If any of the conditions of the Permit are violated, strict action as per the Rules shall be taken.
- 5. The concerned Mamlatdar are directed to demarcate exact area in which deepening other activities may be carried out.
