In exercise of powers conferred by clause (u) of sub-section (1) of Section 2 of the Bharatiya Nagarik Suraksha Sanhita 2023 (No. 46 of 2023) read with Government of India, Ministry of Home Affairs' Notification No. U-11011/2/74-UTL (i) dated 20th March, 1974 and provisions contained at Rule 11 of Chapter - I of the Bombay Police Manual, 1959, the Administrator of the Union Territory of Dadra & Nagar Haveli and Daman & Diu is pleased to direct and declare the Crime Branch of the UT Administration of Dadra & Nagar Haveli to be a Police Station for the exercise of Criminal Jurisdiction over the entire Union Territory of Dadra & Nagar Haveli and Daman & Diu.

The duties of the Crime Branch Police Station in UT of DNH & DD are to investigate the following cases;

- Serious cases / economic offences above Rs. 25 lakhs referred to it by the competent authority.
- Any other case transferred to crime branch by the competent authority.

ORDER

Subject:- Crime Branch Operations.

It is hereby informed that in order to conduct proper and thorough investigation of serious crimes including economic crimes, a Crime Branch has been constituted vide Notification No. DNH & DD/DCB/2025-26/245 dated 23/04/2025 in the UT of Dadra & Nagar Haveli and Daman & Diu.

2. The following procedure shall be followed for handing over the investigations of offences/applications to Crime Branch and for conducting such investigations and for the completion of such investigations.

(1) The Crime Branch shall be entrusted with the investigations of the offences/applications as may be entrusted to it by the Inspector General of Police, Dadra & Nagar Haveli and Daman & Diu as the competent authority. The Crime Branch will have jurisdiction of investigation over such cases referred by the Inspector General of Police, Dadra & Nagar Haveli and Daman & Diu in the entire UT.

(2) The Superintendent of Police (Crime Branch), Dadra & Nagar Haveli and Daman & Diu will be the head of the Crime Branch and will be assisted by the Additional / Deputy Superintendent of Police, Crime Branch along with a Police Inspector along with requisite Police Sub-Inspector / Lady Police Sub-Inspector, Head Constable and Constables.

(3) During each investigation of all the crimes/applications handed over to the Crime Branch, the progress report of the investigation will be sent to the Inspector General of Police, Dadra & Nagar Haveli and Daman & Diu's office every 15 days.
