ORDER

(UNDER SECTION 163 OF THE BHARTIYA NAGARIK SURAKSHA SANHITA, 2023)

WHEREAS, the festival of Eid-ul-Adha (Bakri Id) will be celebrated on June 07, 2025;

AND WHEREAS, in anticipation of any untoward incident and for the maintenance of peace, harmony and tranquillity as well as the prevention of potential disturbances to law and order that may endanger lives and property, it is imperative to issue a prohibitory order;

NOW THEREFORE, in exercise of the powers conferred upon me by section 163 of Bhartiya Nagarik Suraksha Sanhita, 2023 and to maintain peace and tranquillity, **I, Priyank Kishore, IAS, District Magistrate, Daman**, do hereby make this written order that there is: -


1. Ban on sacrificing any bovine or prohibited animal.
2. Ban on sacrificial proceedings in all public areas, including but not limited to (a) Public roads and footpaths. (b) Inside and outside the premises of the hospitals/nursing homes. (c) inside/outside the premises of educational institutions like schools and colleges. (d) Inside and outside the premises of the temple/mosque/religious institutions (e) Inside or outside parks or other public places.
3. Ban on carrying meat or carcass openly in public places.
4. Ban on offering prayers on roads or footpaths.
5. Prohibition of activities inciting communal violence, carrying weapons, disturbing peace and excessively high-volume microphones.

This order shall come into force with immediate effect from **07/06/2025 to 09/06/2025**.

Any person contravening this order shall be punishable under Section 223 of the Bhartiya Nyaya Sanhita, 2023.
