The Auction of Scrapable, unserviceable, obsolete items shall be carried out under the supervision of the Committee consisting of the Chief Town Planner, Town and Country Planning Department, Daman, Joint Secretary (Finance), Finance Department, Vidhyut Bhavan, Daman & Joint Secretary (Home), Home Department, Vidhyut Bhavan, Daman.
2. The interested bidder shall have to deposit a token amount of Rs. 500/- (Which is nonrefundable) in the Town and Country Planning Department, Daman on or before / /2025 upto : a.m.
3. The successful bidder must deposit 25% of the bid amount on the spot and pay the remaining balance before collecting the items. Failure to pay the remaining amount after the auction will result in forfeiture of the initial 25% deposit.
