- 4. **Copy of the Resolution** passed by the General Body approving the proposed amendment(s).
- 5. **Certified Resolution of the Managing Committee** authorizing the office bearers to submit the amendment proposal.
- 6. Duly signed and stamped copies of Enclosures I, II, III, and V, and four (4) copies of Enclosure IV.
- 7. **List of current Managing Committee Members** along with their contact details (phone number and email ID).
- 8. **Timeline:** The complete proposal must be submitted to the concerned Assistant Registrar of Co-operative Societies **within two (2) months** from the date of its approval in the General Body Meeting.
- 9. **Assistance:** In case of any difficulty or clarification, you may contact the Office of the Assistant Registrar of Co-operative Societies of your district.
