## NOTIFICATION

WHEREAS, the draft Town Planning Scheme 04C, 04H and 04I (Nani Daman) was published in the Official Gazette vide Notification No. PDA/DMN/Appr.TPS/230/2025/2369 dated 13/02/2025 for inviting objections from the owners of the plots within the areas covered under the draft Town Planning Scheme 04C, 04H & 04I within 60 days from the publication of the Gazette Notification.

**AND WHEREAS**, the Government has duly approved the Town Planning Scheme 04C, 04H & 04I (Nani Daman) as required under sub-section (3) Section 68 of the said Act.

**NOW THEREFORE**, the Planning and Development Authority, Daman hereby publishes the modified Town Planning Scheme 04C, 04H & 04I (Nani Daman) and informs the general public that the same are available for inspection at the following places.
