(Passed in open court on 16 October, 2023)

1] This is the reference made vide letter No.LE/LL/DMN/FACT-4(7)/2005/1122 made by the Deputy Secretary (Lab. & Emp.), Daman under Sec. 10 (1) of the Industrial Disputes Act in respect of

an industrial dispute between **M/s Hindustan Lever Limited.** and its workman **Shri Bharat N. Patel** in respect of matters (1) pertaining to the settlement between the employer and the workmen.

- 2] Both the parties filed Term of Compromise at Exh. 104 and submit that dispute between them in the instant reference has been settled through Mutual Dialogues in an amicable Environment on following terms:-
- 1. Without Prejudice to the merits and/or contentions raised by either party in the captioned matter, the parties hereto have arrived at an out of Court settlement.
- 2. It is agreed and undertaken by the Second Party that upon the execution of this present Consent Terms, the Second Party shall forthwith withdraw all pending litigations filed by the Second Party against the First Party Company. The litigations which will be withdrawn are: (i) REFERENCE (IDR) NO. 3 OF 2006 filed with the Industrial Tribunal at Daman; and (ii) WRIT PETITION NO. 11098 OF 2014 pending before the Appellate Side of the Hon'ble Bombay High Court (in which an Award passed in the Reference (IDR) No.6 of 2003 has been challenged).
- 3. It is agreed by and between the parties that upon the withdrawal of the above two (2) litigations, the First Party Company shall handover a Demand Draft bearing No. 000067 for a sum of Rs. 4,00,000/- (Rupees Four Lakh Only) drawn on HSBC Bank dated October 12, 2023 in favour of the Second Party, which payment is an ex-gratia amount, paid to the Second Party in full and final settlement of all the Second Party's claim against the First Party, its directors and its representatives.
- 4. The Second Party confirms and agrees to accept the sum of Rs.4,00,000/- (Rupees Four Lakh Only) as full and final settlement of all his claims against the First Party arising out of his employment with the First Party towards full and final settlement of his all claims and demands.
- 5. The Second Party agrees, confirms, and undertakes that he will not raise any dispute and/or demand either monetary or otherwise against the First Party, it's Directors and/or its representatives before any forum.
- 6. The Second Party agrees, confirms and undertakes that on receipt of the sum of Rs. 4,00,000/-(Rupees Four Lakh Only), he has no claim of whatsoever nature left including any claim for reemployment, re-instatement, subsistence allowance or any monetary claim against the First Party, its Directors and/or its representatives.
- 7. The Parties undertake that on fulfilment of the terms as set out in Clauses 2 and 3 of this Consent Terms, the Parties shall not initiate any proceedings against each other and/or their directors, officers, employees, and agents with respect to any and all allegations, demands, claims etc.
- 8. The Second Party acknowledges the sufficiency of Rs.4,00,000/- (Rupees Four Lakh Only) towards the full and final settlement of all disputes between the Parties, and the First Party

acknowledges the sufficiency of the acts of the Second Party under Clause 2 as the full and final

settlement of all disputes between the Parties.

9. Each Party irrevocably and unconditionally discharges forever the other Party and all of their

affiliates, directors, employees, successors, assigns, and representatives respectively, from any

and all past, present or future rights, liabilities, claims, actions, causes of action, costs and/or

demands of any nature whatsoever relating to or arising from the disputes between the Parties

prior to the execution of this Consent Terms.

10. The Second Party, furthermore, will have no claim left in any of the pending disputes pertaining

to wage adjudication and/or subsistence allowance pending before any court or fora and/or

Court/Tribunal and in any event, the Second Party relinquishes all his claims against the First

Party, its Directors and/or its representatives in view of the present Consent Terms.

Whereas an application under the Industrial Disputes Act, 1947 was filed by Shri Vipul Kumar Ramubhai Patel, C/o. Kaushik Kaptan Advocate, 55, Amrut Nagar Society, At Jalalpore, Dist Navsari before the Conciliation Officer, Daman thereby demanding reinstatement of his services with M/s. Om Polyblends, Survey No. 741/6, 8 & 9, Sapna Synthetics India Compound, 1 Floor, Near V Trans, Ringanwada, Daman with full back wages;

And Whereas no amicable solution could be reached during the Conciliation proceeding and therefore a Conciliation Failure Report was submitted by the Conciliation Officer. Accordingly to para 4 of the said Report, an amount of Rs. 3,34,250/- (Rupees Three Lakh Thirty Four Thousand Two Hundred Fifty only) was demanded by the Applicant during the Conciliation Proceeding held on 27-06-2023 towards his dues;

And Whereas the said dispute was referred to the Industrial Tribunal vide Order No. LE/LI/DMN/FACT-135/22/2023/269 dated 13-07-2023 for adjudication as to "whether the demand of the applicant for an amount of Rs. 3,34,250/- (Rupees Three Lakh Thirty Four Thousand Two Hundred Fifty only) towards his dues is justified? 

Reference of Industrial Dispute as per section 10 (1) (c) of the Industrial Dispute Act-1947

Suit proceeded ex-parte against the First Party.

AWARD

(Delivered on 20th Day of November, 2023)

The Appropriate Government Administration of Daman and Diu, U.T., Daman was of the opinion that, an industrial dispute exists between the First party and Second party in respect of the matter of discharge or dismissal of workmen by the management of, or grant of relief to, workmen wrongfully dismissed. Therefore in exercise of the power conferred by clause 'c' of Sub Section 1 of section 10 of the Industrial Dispute Act-1947, the Appropriate Government has referred this industrial dispute for adjudication to this Labour Court of Daman, vide letter bearing No.LE/LI/DMN/FACT- 212/2017/508, dated 12/11/2018, which is received by this Court on 12/11/2018.

- (2) Accordingly notices were issued to both the parties as per procedure prescribed under Section 11 of the Industrial Dispute Act 1947. In response to the notice Second Party appeared before this Court. The Second Party has submitted statement of claim at Exh.08. The First party failed to appear to file reply. Hence, suit proceeded exparte against First Party vide order below Exh. 12 dated 21/04/2022.
- (3) By way of statement of claim the Second Party alleged that, he was the workman of First Party since 01/08/2016 to 27/11/2017 as a machine operator and his salary was Rs. 17,000/- per month sometimes with overtime it comes around Rs. 20,920/-. The First Party illegally removed the employment of the Second Party and terminated his service without assigning any reason on 27/11/2017 when he resumed his duty at 8.00 pm without any proper ground and without paying legal dues. He was neither given any opportunity to be heard nor any disciplinary or documentary enquiry was conducted. No charges were framed or allegations were formed by the First Party. The First Party has not paid any bonus or salary for notice period to the Second Party. The termination of his employment effected by the First Party is illegal, improper, malafide and arbitrary. Thus, Second Party prayed to reinstate him as workman in the employment of the First Party and with full back wages from 27/11/2017.
- (4) Second Party has alleged that he was illegally terminated from his service by First Party Company. However, Second Party failed to lead evidence. Therefore, evidence of Second Party has been closed vide order dated 05/10/2023. Moreover, Second Party has failed to substantiate his claim. The Second Party has not adduced any evidence. Thus, he has failed to substantiate his claim and therefore, I answer the reference in the negative and accordingly disposed off.


