### NOTIFICATION

**WHEREAS**, a proposal had been received from the Chief Executive Officer, District Panchayat, Daman / DNH for rationalizing the number of Gram Panchayats for enhancing efficiency on account of Administrative needs in Daman / DNH.

**WHEREAS**, the following Gram Panchayats were consulted for the exclusion of Territorial Areas on special Gram Sabha on account of Order No. F. No. JS/PRI/GP-SPL-Meeting/2025/272, dated 29/07/2025, issued by the Joint Secretary PRI, UT of DNH & DD Under Section 6 of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012, and the same were held on dates cited hereunder for creation of new Gram Panchayats from the excluded territorial areas, in which the said Gram Panchayats has resolved to create new Gram Panchayats by excluding existing territorial areas, as under;

**AND WHEREAS**, the Administrator, UT of Dadra and Nagar Haveli and Daman & Diu, on due consideration of the above proposal and after making such inquiries as thought necessary considered the consultation of Panchayat Resolution of abovesaid Gram Panchayats for creation of additional Gram Panchayats from said Gram Panchayats.

**NOW THEREFORE**, after making such inquiries as deemed necessary, in exercise of his powers under clause (b) of sub-section (1) of section 6 of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012, the Administrator of UT of Dadra and Nagar Haveli and Daman &
