No. 7-2/EC/DNH&DD/2022: Whereas, the Administrator, Dadra and Nagar Haveli and Daman and Diu, had called upon Maharani Laxmibai Gram Panchayat, Vanakbara Gram Panchayat, Maharana Pratap Gram Panchayat, Saudwadi Gram Panchayat, Shaheed Bhagat Singh Gram Panchayat and Sardar Vallabhbhai Patel Gram Panchayat in Diu District vide Notification No. 05/06/GENL.ELEC. No. 7-2/EC/DNH&DD/2022(A): Whereas, three casual vacancies of ward members had occurred in PRIs in the UT of Dadra and Nagar Haveli and Daman and Diu, two in Gram Panchayat Zolawadi in Diu District i.e Ward No. 1/8 and Ward No.4/8 and one in Dadra Gram Panchayat in Dadra and Nagar Haveli District i.e Ward No. 3/11 due to resignation/death of members;
