Whereas, Section 5(1) of the Right to Information Act, 2005 requires every public authority to designate as Central Public Information Officers (CPIO) as may be necessary to provide information to persons requesting for the information under the RTI Act.

And Whereas, Section 19 (1) of the Act provides that any person who does not receive a decision within the prescribed time or is aggrieved by a decision of the CPIO, may prefer any appeal to such officer who is senior in rank to CPIO and is referred to as First Appellate Authority.

Now therefore, in supersession of Order & Notification referred in the preamble above, the Administrator, Dadra & Nagar Haveli and Daman & Diu is pleased to re-designate the officers indicated in column (3) as CPIO and the officers indicated at column (4) as the First Appellate Authority in Annexure-I, Annexure-II and Annexure-III for the Dadra & Nagar Haveli, Daman and Diu Districts respectively.
