WHEREAS, after the merger, the President of India was pleased to promulgate the extension of the regulation of the Dadra and Nagar Haveli Municipal Council Regulation, 2004 as amended in 2018 to the Daman and Diu and was named as Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation, 2004.

AND WHEREAS, following thorough deliberations and detailed analysis of each sections of the regulation, and with the invaluable assistance of a legal team, a suggestive amendment to section 11 of the regulation was prepared.

11. Division of municipal area into wards and reservation of wards for women, scheduled castes and scheduled tribes.
