Whereas, the Administrator of the Dadra and Nagar Haveli and Daman and Diu has determined the total number of seats (including the Sarpanch) for each Gram Panchayat and each District Panchayat in the Union Territory of Dadra and Nagar Haveli and Daman Diu vide Notification No JS/PRI/GPDP/SN/DELI/2025/299 dated 7<sup>th</sup> August 2025;

And whereas, Rule 3 (1) (b) of the Dadra and Nagar Haveli and Daman and Diu Panchayats (Election Procedure) Rules, 2023 provides that wards in which seats are reserved for the Scheduled Castes, the Scheduled Tribes, women belonging to these castes or tribes and Women shall, as far as practicable, be distributed in different wards of Gram Panchayats and District Panchayats, and they shall be rotated by the Commission by draw of lots so that it is ensured that seats are so reserved in all wards of Gram Panchayat and the District Panchayat, as the case be, before such reservation is made in respect of a ward for the second time.

And whereas, in compliance thereto, a draw of lots was held at Conference Hall, Circuit House, Jalandhar Beach, Diu in respect of Gram Panchayats & District Panchayat in Diu District on 22<sup>nd</sup> September, 2025. Similar draw of lots were held at Vivekananda Hall, Nani Daman on 23<sup>rd</sup> September, 2025 in respect of Gram Panchayats & District Panchayat in Daman District as well as at Dr. APJ Abdul Kalam Auditorium, Silvassa on 24<sup>th</sup> September, 2025 in respect of Gram Panchayats & District Panchayat in Dadra and Nagar Haveli District, in the presences of representatives of Political Parties and other interested in the subject to identify the seats reserved for Women, the Scheduled Castes, the Scheduled Tribes and women belonging to these Castes or Tribes in Gram Panchayats, offices of Sarpanches of the Gram Panchayats and District Panchayats;

Now, therefore, consequent to the draw of lots and in pursuance of sub-section(5) of 12 and sub-section (5) of Section 55 of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012 read with Rule 3 (1) (b) of the Dadra and Nagar Haveli and Daman and Diu Panchayats (Election Procedure) Rules, 2023, the Election Commission hereby allots the seats reserved for Women, the Scheduled Castes, the Scheduled Tribes and women belonging to these Castes or Tribes in the Gram Panchayats, offices of Sarpanches of the Gram Panchayats and District Panchayats in all the districts of UT of Dadra and Nagar Haveli and Daman and Diu, as shown in the Schedules- “A to I”, appended to this order respectively for the forthcoming General Election.

Whereas, the Administrator of Dadra and Nagar Haveli and Daman and Diu has determined the total number of seats and the seats to be reserved for Women, the Scheduled Castes, the Scheduled Tribes and Women belonging to these castes/tribes in Daman Municipal Council and Silvassa Municipal Council, vide Notification No. UD/DNH/Muni/Res./Women/99/2017/42 dated 5<sup>th</sup> October 2020;

And whereas, Rule 3(1)(b) of the Dadra and Nagar Haveli and Daman and Diu Municipal Councils (Election) Rules, 2025 provides that wards in which seats are reserved for the Scheduled Castes, the Scheduled Tribes, Women belonging to these castes or tribes or Women shall, as far as practicable, be distributed in different wards of each Council;

And whereas, Rule 3(1) (c) of said rules provides that the seats reserved under clause (b) may be rotated by the Commission by draw of lots separately for the Scheduled Castes, the Scheduled Tribes and the Women so that it is ensured that seats are so reserved in favour of such Castes, Tribes or Women in all the wards before such reservation is made in respect of a ward for the second time for that category:

And whereas, in compliance thereof, a draw of lots was held in the Vivekananda Auditorium, Nani Daman on 23<sup>rd</sup> September 2025 for Daman Municipal Council and a similar draw of lots was held at Dr. APJ Abdul Kalam Auditorium, Silvassa on 24<sup>th</sup> September 2025 for Silvassa Municipal Council, in the presence of representatives of political parties and others interested in the subject;

Now, therefore, consequent to the draw of lots and in pursuance of Section 10 (4) of the Dadra and Nagar Haveli and Daman and Diu Municipal Council Regulation, 2004 read with Rule 3(1) (b) & (c) of the Dadra and Nagar Haveli and Daman and Diu Municipal Councils (Electron) Rules 2025, the Election Commission hereby allots the seats reserved for the Scheduled Tribes, women belonging to the Scheduled Tribes and Wornen in Daman Municipal Council and Silvassa Municipal Council in the UT of Dadra and Nagar Haveli and Daman and Diu, as shown in Schedule- A & B append to this order respectively, for the forthcoming General Elections.
