1. The rates for the above work should be including of all taxes.
2. The reserve price is fixed for Dismantling/ Demolition of the existing Building including disposal of all Serviceable & unserviceable material from the site.
3. Sealed envelope should be super scribed word **“Auction for Obsolete/Unserviceable materials under Silvassa Municipal Council”**.

4. The highest bidder will have to deposit full amount offered by him by DD within 3 days from the issue of letter accepting his bid.
5. The work should be completed within 30 days after issuing the order by this Department.
6. The Agencies/Contractors should quote their rates in their own letter pad OR on plain paper with their rubber stamp.
7. Tender Fees of Rs.500/- (Non-refundable) should be submitted in favour of the undersigned (Chief Officer, Silvassa Municipal Council) in the form of Demand Draft.
8. EMD for an amount of Rs. 30,270/- (Rupees Thirty Thousand Two Hundred Seventy Only) should be submitted in favour of the undersigned (Chief Officer, Silvassa Municipal Council) in the form of Demand Draft/Fixed Deposit Receipt.
9. Bidder should submit the valid firm registration/firm license, GST, Pan Card.
10. The Tenders shall be considered invalid and non-responsive for non-submission of any document stipulated herein. (Tender Fees, EMD)
