 $\frac{\textbf{AWARD}}{(\text{Delivered on } 26^{\text{th}} \, \text{Day of September}, 2025)}$

This is a reference received from the Commissioner (Labour) under section 12(5) of The Industrial Disputes Act, 1947 (hereinafter referred to as "The Act'). It has been stated in the reference that an industrial dispute exists between M/s Croma Polymers company and its workman Shri Rambhajan Singh. The management of the company and the workman were called for conciliation. However, the management failed to appear inspite of receiving notice. Therefore it seems that the management is not interested to settle the dispute. Hence, no conciliation could be reached out during the conciliation proceeding. Hence the Conciliation Officer i.e. the Commissioner of Labour has made this reference to the Labour Court to decide the issue whether the demand of the applicant workman for an amount of Rs. 68,225/- towards his dues like salary, bonus, leave salary, etc. is justified? If yes, what relief the workman is entitled to?

- 2) After receiving this reference, notices were issued to the workman (second party) and the company (first party). Accordingly, the second party workman Shri Rambhajan Singh appeared before the Court and filed his statement of claim on 20.09.2022. Despite of receiving the notice vide Exh. 3 on 23.11.2021 no person from the first party company appeared before the Court. Therefore, the reference proceeded ex- parte against the first party company vide the order below Exh. 1 dated 26.06.2023. Thereafter, the workman filed his affidavit in lieu of examination-in-chief vide Exh. 9 and has also examined a witness namely Subhash Pandey vide Exh. 10. He has also relied upon the documents i.e. his original passbooks of Bank of Baroda of Account No. 02370100025125 from 31.12.2017 to 17.07.2020 and from 17.07.2020 to 28.10.2021.
- 3) In his affidavit, the second party workman has deposed that he was a workman of the M/s Croma Polymers the first party company situated at S.No. 390/1, Plot No. 22, Gala No. 115, Modern Industrial Estate, Kachigam, Nani Daman, Daman and was working as an operator (extrusion machine). He was drawing salary of Rs. 17,000/- per month. The company used to credit salary directly in his account. He had worked hard and with full dedication in the company during his tenure. He further deposed that he had gone to his native place for attending wedding of his close relative by availing leave from manager Shreelal Sharma, for one week. When he resumed his job there was nationwide lockdown declared by the Government. During Covid Pandemic he had applied for and was issued entry exit pass i.e. e-pass from Daman Administration to travel to Daman from Vapi. He further deposed that on 01.11.2020 he reached the company at 08.30 am. At that time manager Shreelal Sharma was present at the main gate and informed him that he has been terminated from his services. Therefore, he requested the manager to give him a month's time to search another job. However, the manager stated that his services are no more required. Hence, he requested to pay his dues including bonus, notice pay, etc. However the manager informed him to contact him tomorrow. Thereafter, he kept contacting the manager on his mobile phone and kept requesting him for his dues. But the manager did not pay any heed. Despite of repeated requests, his legal dues are not given by the company. Therefore, he

approached to the Labour Office, Daman with an application complaining about his illegal termination. The Labour Office issued notice to the respondent company time to time and also fixed hearing on 12.01.2021, 15.02.2021, 04.03.2021, 18.06.2021, 05.07.2021 and 26.07.2021. However, the respondent company management did not appear before the Conciliation Officer even once. Therefore due to non appearance of the respondent company before the Labour Commissioner, Daman, the matter could not be resolved. Hence the dispute was forwarded before the Labour Court, Daman for adjudication.

- 4) The workman further deposed that his salary used to get credited in his savings account opened by the respondent company in Bank of Baroda, Vapi Branch bearing Account No. 02370100025125. The passbooks, which are filed on record at Exh 18 and 19, show that he was getting salary from the first party Croma Polymers. The reason of termination was also not communicated to him by the respondent company till date. The respondent company has illegally terminated him from employment without any reason and without giving any notice, hence his termination is illegal and due to his illegal termination he was starved in pandemic situation and he was unable to perform his duty towards his family and fulfill daily needs of food and daily expenditure including medical expenses of his family. He further deposed that he is in need and have to maintain his family consisting of wife and school going kid. He deposed that he is legally entitled for the total amount of Rs. 68,225/- towards one month salary, notice pay of one month, leave payment of 8 days, lock-down half salary of two months and bonus. Witness Subhash Pandey has also deposed that the second party workman Rambhajan Singh was working as an operator of extrusion machine in the Croma Polymers Company since February, 2020 and was getting salary of Rs. 17,000/- per month. However, he was terminated from services without any notice.
- The evidence of second party workman Rambhajan Singh and witness Subhash Pandey has gone unchallenged as the management of the first party M/s Croma Polymers company opted for not to appear before the court, despite of receiving notice. The record also reveals that no person from the first party company appeared before the Conciliation Officer i.e. the Commissioner (Labour) for conciliation, in the year 2021 and therefore the Commissioner (Labour) sent this reference before this Court vide its order dated 15.10.2021 as the conciliation could not take place. Even after receiving the notice of this Court the company has chosen not to appear before the Court and to file any reply to the claim filed by the second party workman. This approach of the company management shows their disrespect towards the due process of Law. Secondly, the contents of the affidavit of second party workman transpires that the management has not considered the vulnerable financial condition of the workman in the prevailing Covid Pandemic time. They have abruptly terminated the services of the claimant without giving any notice to him and even avoided to make payment of the legal dues for which the second party workman was entitled. This shows the management's indifferent approach and lack of sympathy towards its workers.

I.D.R.No. 07/2021

By filing this claim, the second party workman has prayed for Rs.17,000/- towards one month salary, Rs. 17,000/- for notice pay of one month, Rs. 5,225/- towards leave payment of 8 days, Rs. 17,000/- towards lock-down half salary of two months and Rs. 12,000/- towards bonus which is amounting to Rs. 68,225/-. The amount which the second party workman has asked for is as per the provisions of The Act and The Payment of Bonus Act, 1965. The claimant has not asked for any exorbitant dues. He has prayed for the legal dues for which he is entitled. Therefore, I hold that the claimant is entitled for the relief claimed. The issues under reference are answered accordingly.

7) The record reveals that the first party company intentionally neither appeared before the Conciliation Officer nor before this Court. Therefore the second party workman had to run from pillar to post to receive his own legal dues. Hence considering the plight of the second party workman, it will be expedient and justifiable to recover the costs of the litigation from the first party company. In view of all these observations I do not find any impediment to allow the claim of the second party workman Rambhajan Singh alongwith cost of Rs.20,000/-. Hence the following award is passed.

ORDER

- (1) The reference is allowed.
- (2) The first party company is directed to pay Rs. 68,225/- to the second party workman along with Rs. 20,000/-towards cost of this litigation (total Rs. 88,225/-) within one month from the date of publication of the Award, failing which the first party company will be liable to pay interest @ 12% p.a. on the said amount till its realization.
- (3) A copy of the award be sent to the Commissioner (Labour) for its publication.
