Applications are invited on the establishment of District & Sessions Court, Dadra and Nagar Haveli, Silvassa from eligible candidates for the 01 post of **Stenographer (Lower Grade)** on **short term contract basis** on a consolidated fixed monthly salary of **Rs.25,000/- (Rupees Twenty Five Thousand only)** with a break of 02 days after every set of 06 months till a regular Stenographer (Lower Grade) is appointed by this Court, as per the eligible criteria given below:-

| Age Limit | The age limit for the post should not be less than 18 years and more than 38 years of age in case of General Category and 43 years in case of candidates belonging to Scheduled Caste, Scheduled Tribe, Other Backward Class or Special Backward Class as specified by the Government. |

Eligibility Criteria:-

- (I) Qualification: A candidate for being eligible;
 - (a) Must possess Degree from any recognized University.
 - (b) Adequate knowledge of the regional language of the Court in the District.
 - (c) Qualify Government Commercial Certificate (G.C.C.) Examination or examination conducted by Government Board or Government Certificate in Computer Typing Basic Course (GCC-TBC or I.T.I.) for <u>speed of 100 w.p.m.</u> <u>or above</u> in <u>English Shorthand</u> and <u>minimum English Typing speed of 40 w.p.m.</u>



- (d) Possess <u>Computer Certificate</u> about proficiency in operation of word processor in Windows and Linux in addition to M.S. Office, M.S. Word, Wordstar-7 and Open Office Org. obtained from any of the following Institutes:
 - a) Statutory Universities in the States or U.T's, as the case may be.
 - b) State Board of Technical Education, as the case may be.
 - c) NIC

- (III) Candidate shall not be eligible for appointment if he/she has been convicted for an offence involving moral turpitude or he/she is or has been permanently debarred or disqualified by the High Court/District Court or the Union Public Service Commission or any State Public Service Commission from appearing for examinations or selections conducted by it.

COMMON INSTRUCTIONS TO THE CANDIDATES APPLYING FOR THE POST OF STENOGRAPHER (LOWER GRADE) ON CONTRACT BASIS.

- Candidates must carefully read all the instructions displayed here before actually submitting applications, so as to avoid mistakes.
- Candidates may send their applications in the prescribed Format as given in the Advertisement by Registered Post (with Acknowledgement Due) or by Speed Post or personally at their own cost to the office of the Registrar, District & Sessions Court, Dadra and Nagar Haveli, Silvassa – 396 230 on or before 20.12.2025 during the office hours.



- To avoid last minute rush, the candidates are advised to submit the application well in advance.
- Candidate must state whether he would like to be considered as one belonging to reserved category or as general category candidate. If a candidate opts to be considered for the reserved category and does not produce the certificates entitling him to be considered in the concerned category, he would be disqualified for furnishing wrong information and would not be considered against general category.
- The candidate should not send any original copies of the documents/ 5. certificates at the stage of submitting application form.
- Candidates may note that, their eligibility would be assessed on the 6. information furnished by them believing that the information is true and correct. If any candidate is found to have given false, wrong or incorrect information, such candidate would not only be disqualified but may also face prosecution. Such candidates would be debarred from appearing in any examination for applying for the post under the District & Sessions Court.
- For the post of Stenographer (Lower Grade) the candidate shall have to 7. appear in the Speed Test of 20 marks in Shorthand in English Language. Particulars of the said test is as below:-
