NOTICE

WHEREAS, vide Preliminary Notification No. 65-05-LAQ-2022-23/1190 dated 19/11/2024, it was notified under Section 11 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land described in the schedule hereto (thereafter referred to as the said land) were needed or likely to be needed for the public purpose, namely Additional Land Acquisition from Malala Junction to Bucharwada Fatak for Strengthening and Widening of NH-251 from Km 11.000 to Km 22.770 at District Diu;

AND WHEREAS, a report was submitted to the appropriate Government i.e. Hon'ble Administrator of Dadra & Nagar Haveli and Daman & Diu to proceed with the acquisition process and the same has been approved;

AND WHEREAS, vide Declaration No. 65-02-LAQ-2022-23/1060 dated 18/11/2025, it was declared under the provision of Section 19 of the Right to Fair Compensation, Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 that the said land is required for the public purpose, namely Additional Land Acquisition from Malala Junction to Bucharwada Fatak for Strengthening and Widening of NH-251 from Km 11.000 to Km 22.770 at District Diu;

AND WHEREAS, in connection with acquisition of land admeasuring **4530.00** sq. mtrs. for Additional Land Acquisition from Malala Junction to Bucharwada Fatak for Strengthening and Widening of NH-251 from Km 11.000 to Km 22.770 at District Diu, the Administration of Dadra & Nagar Haveli and Daman & Diu intends to take possession of the land, the particulars of which is given in the declaration u/s 19(1) No. 65-02-LAQ-2022-23/1060 dated 18/11/2025 of the Right to Fair Compensation & Transparency in Land Acquisition Rehabilitation and Resettlement (RFCTLARR) Act, 2013;

AND WHEREAS, under Section 21 of the RFCTLARR Act 2013, the Government intends to take possession of the land, and the claims to compensation and Rehabilitation and Resettlement for all interests in the land, has to be submitted to the Collector for disposal on or before 17/12/2025 at 18.00 hrs:

AND WHEREAS, the details of compensation on the land acquisition as per the **Annexure** – **I, II, III** are enclosed herewith;

AND WHEREAS, under sub section (1) & (2) of Section 22 of the said Act, the Collector may also require any such person to make or deliver to him/her a statement containing the name of every other person possessing any interest in the land or any part thereof as co-proprietor, sub-proprietor,

mortgage, tenant or otherwise, and of the nature of such interest, and of the rents and profits, if any received or receivable on account thereof for three years next preceding the date of statement;

NOW THEREFORE, to facilitate causation of the above requirements, public notice is hereby served under section 21 of the RFCTLARR Act, 2013 that all persons having interest in the said land to appear personally or by agent or advocate before the Collector, Diu on 18/12/2025 at 13.00 hrs., and to state in writing and signed by the party or his agent, the following:

- a) The nature of their respective interest in their land;
- b) The amount and particulars of their claims to compensation for such interests;
- c) Their objection if any to the measurements made and marked on the referred area.

Please take notice that, as provided under sub-section 22 of the aforesaid Act, every person required to make or deliver a statement under this section shall be deemed to be legally bound to do so within the meaning of section 175 and 178 of the Indian Penal Code (45 of 1860).

The U.T. Administration of Dadra and Nagar Haveli and Daman & Diu is of the opinion that an Industrial dispute exists between M/s.
